3- The matter concerns the block development officer, development block-City, District- Mirzapur Uttar Pradesh. The matter comes under the supervision of block development officer-City block, District- Mirzapur.

Gram Panchayat Lohandi Kala, Block Development Officer City Block, Development block -City, Bhujwa Ki Chowki

The matter concerns corrupt pictures uploaded in reference to upload of information board images on the website of gram Panchayat development plan of the Government of India under the monitoring of block development officer, development block City, district Mirzapur.

4- Right to information act 2005 was introduced by the government of India to promote transparency and accountability in the working of the public authorities so that growing corruption in the working of public authorities like jungle fire must be controlled but it seems that corruption in the government machinery itself controlled the right to information act 2005 by diluting the provisions of the right to information act 2005 in crypted way.

The matter concerns the deep rooted corruption in the developmental activities being carried out in the development block City under the monitoring of the concerned block development officer and assistant development officers.

- 3- Please provide the name and designation with posting details and date of joining the block City of the staff who monitors the upload of Public information board images on the government website of gram Panchayat development plan.
- 4- Block development officer City block Mirzapur may provide the current status of the wall painting of the developmental activities carried out in the village panchayat- Lohandi Kalan/Bhujwa Ki Chowki, Development block-City, Tehsil-Sadar, Police Station-Kotwali Dehat, district-Mirzapur, Uttar Pradesh, PIN Code-231001 belonging to the development block City Mirzapur.
- 5- Please provide the name and designation of the monitoring body who monitors the upload of public information board images on the website of the government and mechanism to

award punishment in case of irregularities in uploading the images.

6- Please provide the name and designation of the public staff under whose monitoring Public information board images of gram Panchayat Lohandi Kala was uploaded on the website of the government. Also provide the date of joining of this public staff to the city block.

This is a humble request of your appellant to you Hon'ble Sir that the matter concerns the working of the Chief Development Officer district-Mirzapur whose public information officer is the district development officer Mirzapur Shraavan Kumar Rai itself. It is quite obvious that concerned district development officer is not providing information to the information seeker which is violation of the provisions of the right to information act 2005 by the District Development Officer.
