application and first appellate authority also did not take any action on RTI appeal.
The matter concerns the wilful denial of information by public information officer so
action must be taken against him under section 20 of the right to information act
2005 and disciplinary proceedings must be initiated against the first appellate authority
for colluding with the public information officer in denying information cryptically.

Short submissions of the appellant are as follows.

1- Most respected Sir, from the following status, it is quite obvious that the appellant
submitted the online rti application before the Nagar Nigam Prayagraj on 6th October
2024 which was received in the office of Public Authority on the same date which
means more than three months 16 days passed but the concerned public information
officer did not provide information to the information seeker which is the violation of
subsection one of section 7 of the right to information act 2005.

2- From the following status of the submitted RTI first appeal, it is obvious that the appellant submitted the appeal on 9th December 2024 which was received in the office of Public Authority on the same date.

This implies that the first appellate authority did not entertain the RTI appeal submitted by the appellant.

3-It is most unfortunate that nodal Officer of the department did not provide the details of the First appellate authority on the RTI portal of the Government of India which is tantamount to indiscipline as well as he had to provide the name and designation along with the official mobile number of the first appellate authority but unfortunately not provided which is a violation of the direction issued by the ministry of the department of administrative reform government of Uttar Pradesh.

4-Most respected Sir, the appellant sought following information from the public information officer which is as follows.

1- Provide the posting details of all the first class and second-class employees of the department, the date on which they started service in Prayagraj district and for how long they have been posted, where was their first posting. Also provide their CUG mobile numbers which is necessary in wide public interest.

2- Sir, please provide the posting details of all the third-class employees of the department and the details of the date of commencement of their service in the

they have come to the office of Nagar Nigam Prayagraj, after being transferred.

3- Sir, the posting details of all the class IV employees of the department posted in the office of Nagar Nigam Prayagraj, and the details of the date of commencement of service in the office of Nagar Nigam Prayagraj, and if they have been transferred from other districts to the office of Nagar Nigam Prayagraj, then also provide the details of that.

3- Sir, please provide to the applicant whether the new transfer policy issued by the state government is being followed in the office of Nagar Nigam Prayagraj, or not and if it is being followed, then how has it happened till date, with the step-by-step efforts taken in that direction, the applicant must be informed.

5- Most respected sir new transfer policy attached with this representation which must be considered before providing the information to the information seeker by public information officer in the office of Nagar Nigam Prayagraj.

This is a humble request of your appellant to you Hon'ble Sir that how can it be justified to withhold public services arbitrarily and promote anarchy, lawlessness, and chaos arbitrarily by making the mockery of law of land? There is need of the hour to take harsh steps against the wrongdoer to win the confidence of citizenry and strengthen the democratic values for healthy and prosperous democracy. For this, your appellant shall ever pray for you, Hon'ble Sir.
