1- Public information officer provided following information earlier as aforementioned. Waiting list for 17000 plus contractual vacancies can be issued on 26.11.2022 after approval from the competent level. Public information officer must provide the information about the competent label.

2- The Public information officer must provide the mechanism of the approval for the waiting list by the competent level. 3- PIO of the National Health Mission must provide the posting details including name and designation of the public staff included in the competent level.

4- Right to Information Act 2005 was introduced by government of India to promote transparency and accountability in the working of public authorities and this act was published in 2005 and it is 2025 which means more than 19 years passed but most unfortunate thing is that public information officers are not providing information within stipulated 30 days which is a mockery of the provisions of the right to information act 2005.

5- Concerned PIO National Health Mission Uttar Pradesh

It is most surprising that a public staff Whose rank is of Deputy general manager NDC does not know the prescribed time to provide information to the information seekers is a matter of serious concern and I think that accountable staff of the government must meditate on it.

To ensure transparency and accountability in the government machinery, this act was introduced so that growing corruption in the government machinery could be controlled, but instead of controlling the corruption of government machinery the

rampant corruption in the government machinery itself diluted the provisions of right to information act 2005.

If any new vacancies arise for any districts for aforesaid advertised positions OR any new position arise having same advertised essential qualification and same maximum upper cap of honoraria during this period, same will be filled up from the existing waitlist.

Most respected sir both public information officer and first appellate authority made the mockery of the provisions of right to information act 2005 so harsh steps must be taken under section 20 of RTI act 2005 against PIO and disciplinary action against FAA.
