It is submitted before the most respected sir that concerned first appellate authority did not entertain the RTI appeal of the appellant which is against the spirit of the provisions of right to information act 2005 and is illegal so action must be taken against the first appellate authority for taking under teeth the provisions of the right to information act.

3- It is submitted before the most respected sir the appellant sought following information from the public information officer which is still awaited from the public information officer.

The appellant is seeking the following five points from the public information officer Manish Kumar Srivastava whose designation is executive engineer electricity distribution division 2nd Mirzapur currently.

1- Please provide the connection details of Mr Tarak Nath Yadav S/O Avadhraj Yadav who is the elder brother of the aggrieved information seeker Mr Lok Nath Yadav who had taken legitimate connection from the Department of electricity and black cable of two cores belongs to him.

2- Please provide the connection details taken by Mr Tarak Nath Yadav S/O Avadhraj Yadav in the name of his wife at some distant place from this premise.

3- There is heavy dues in the name of Mr Tarak Nath Yadav which is the Root Cause second connection was not provided in his name by the Department of electricity as well as this connection was not disconnected because of the heavy dues of the electricity bills.

Please provide the latest bill of this premise in the name of Mr Tarak Nath Yadav by the Department of electricity.

4- Please provide the details if the legitimate connection provided to Mr Tarak Nath Yadav was disconnected by the Department of electricity and also made available the copy of application made Tarak Nath Yadav S/O Avadhraj Yadav to do so.

5- Please provide the posting details of Mr Kisan Lal Sharma junior Engineer of the Department of electricity and date when he joined local office district mirzapur of the department of electricity.

4-The matter concerns the checking carried out by Junior Engineer Kishan Lal Sharma on 26th October 2024 subsequently served notice to two innocent people on date- 4th November 2024 whose descriptions are as follows. This was not a routine checking carried out by a junior engineer but planned specific checking as a conspiracy against aggrieved people.1- Loknath Yadav S/O Avadhraj Yadav and 2-Kedar Nath Yadav S/O Avadhraj Yadav

Residents of village and Post- Dugauli, police station-Jigna, powerhouse- Jigna district Mirzapur, Uttar Pradesh,

5- If the proper and explicit information be made available by the Department of electricity, then conspiracy made by elder brother by colluding with the junior engineer be exposed.

authorities but it is most unfortunate that no public information officer is providing information under the right to information act 2005 so this question arises whether the act will achieve its goal.
