2- Social Welfare Officer District Mirzapur may tell the applicant that on which date he joined in Mirzapur District, what was his post at that time

3-All the Class I category employees in the social welfare office Mirzapur, their district joining date posting details should be made available to the applicant.

4-Provide the posting details of all the Class 2 category employees in the social welfare office Mirzapur, the date of joining in the district, to the applicant. If posted earlier besides the current posting, then also provide the earlier posting details of the employee.

5- Provide the joining date posting details of all the third-class employees in the social welfare office in the district Mirzapur to the applicant. If posted earlier besides the current posting, then also provide the earlier posting details of the employee.

6-Provide joining date and work details of all class IV employees of social welfare office in the district Mirzapur. If posted earlier besides the current posting, then also provide the earlier posting details of the employee.

5- Most respected sir, when an officer or an employee joins the office of social welfare officer Mirzapur then such record is available to the public authority social welfare office Mirzapur not government.

6-The matter concerns the working of the social welfare officer District Mirzapur as there is complete mismanagement in his working and the need of our is to fix transparency and accountability in the working.
