4- Most respected Sir, District Panchayat Raj Officer Mirzapur denied information with the following remarks.

6- It is most unfortunate that district panchayat Raj officer Mirzapur did not make compliance of the senior rank officers and no information was made available by him thereafter the appellant made the second rti application by seeking the same information and in this rti application he is again running away from providing information to the appellant on the flimsy ground which is not only illegal but also promoting corruption in the department.

7- Right to information act 2005 was introduced by the government of India to promote transparency and accountability in the working of the public authorities but it is most unfortunate that public information officers are not providing information to conceal the corruption under right to information act 2005.

8- Here it is obvious that district panchayat Raj officer Mirzapur not only violated the provisions of right to information act 2005 but also overlooked the directions of the senior rank officers in the matter which concerns the wide public interest.

This is a humble request of your applicant to you Hon'ble Sir that how can it be justified to withhold public services arbitrarily and promote anarchy, lawlessness, and chaos arbitrarily by making the mockery of law of land? There is need of the hour to take harsh steps against the wrongdoer to win the confidence of citizenry and strengthen the democratic values for healthy and prosperous democracy. For this, your appellant shall ever pray for you, Hon'ble Sir.
