6- Most respected Sir, the appellant is not satisfied with the disposal dated 14th February 2025 as the aforementioned. Please direct the public information officer to provide the 5-points of information to the appellant at the earliest.

Most respected sir both public information officer and first appellate authority made the mockery of the provisions of right to information act 2005 so harsh steps must be taken under section 20 of RTI act 2005 against PIO and disciplinary action against FAA.
