ORDER

The Appellant has preferred the instant 1st Appeal dated 19/06/2025 under Section 19(1) of the Right to Information Act, 2005 in reference to his RTI Application Registration No. NICHQ/R/E/25/00295 dated 21/04/2025.

2. In the original request, the RTI applicant Shri Yogi MP Singh requested to provide the following information:-

iii. Please provide the total budget spent by the government of India on the maintenance of the public grievance portal in the financial years 2021-22, 2022-23, 2023-24, 2024-25 respectively.

iv. Please provide the name and designation of the public staff who monitor the functioning of the public grievance portal of the government of India.

v. Please provide the total budget spent by the government of India on the maintenance of the RTI portal in the financial years 2021-22, 2022-23, 2023-24, 2024-25 respectively. This is a humble request of the information seeker to the public information officer that public information officer must provide 5 points information at the earliest within stipulated 30 days as prescribed under subsection one of section seven of the right to information act 2005 etc.

3. The CPIO, NIC responded on 05/05/2025. As per information provided by concerned Division.

4. Aggrieved with the reply, Shri Yogi MP Singh has filed RTI Appeal vide registration no. NICHQ/A/E/25/00093 dated 19/06/2025 stating that refused to provide the information requested.

5 . After a thorough review of the RTI application, it has been observed that the information provided by CPIO(NIC) on 05/05/2025 for the RTI query/ application dated 21/04/2025 deemed appropriate. Hence, the appeal is disposed of.
