1- Most respected sir following notice issued by respected information commission to provide information to the information seeker on 12.12.2024.

Order

Call was given. Both the parties are absent. It is clear from the perusal of the file that the desired information has not been provided to the appellant in the order of his original application.

Therefore, in the interest of justice, a notice should be issued to the Public Information Officer, Office of Vice President, Lucknow Development Authority, Lucknow, attaching a copy of the original application of the appellant, that he should send the complete information to the appellant in the order of his original application as per the rules through registered post within the next two weeks and present the copy of the information and proof of sending it before the Commission on the next hearing date of the case, otherwise why can't punitive action be taken against you as per rules under Section 20 (1) and 20 (2) of the Right to Information Act 2005. Appear for next hearing on 30.12.2024 for appeal.

2- Sought information by the appellant are as follows.

1-L.D.A. may provide the details of title suit filed by multi-named lady Anuradha Singh in the record of L.D.A. Guddi Singh including the designation, name of the public staff who executed it with posting detail.

2-L.D.A. may provide the copy of the order passed by the competent court deciding the title suit of the Anuradha Singh in the compliance of the High court order in the Writ Petition Number 135 HC Year 2006.

3-L.D.A. may provide the detail of the posting of the staff executing the registry of impugned plots to allottees with designation and name so that accountability may be fixed.

4-Detail of the committee setup to check the irregularities including name, designation and posting details of its members which may include date of joining the department.

5-PIO may provide the details of government functionaries nominated the members of the committee including posting details and stipulated time given to the committee to complete the enquiry.

3- In compliance with the notice dated 12th December 2024 the public information officer provided five points of information as follows.

Regarding the above, it is to be informed that necessary action is being taken as per rules by forming a committee in the matter in question. As per the instructions of the committee, after obtaining the on-site report, letters were sent several times to the allottees of the concerned plots and the complainant to appear in the office with the records/evidence and talks were also held over the telephone. Both the parties are not appearing in the office with the desired original records/evidence, only the application form is submitted, due to which further action is not being taken regarding the decision of the committee constituted for the settlement of the matter in question. In this regard, information has been sent to both the parties through various letters to appear before the constituted committee with the original records. After both the parties are available in the office with the desired original records/evidence before the constituted committee, further action will be taken as per rules. The actual situation in this regard has already been informed. Please take the trouble to become aware of the above report. Please take a glance at the attached PDF document to this email representation which is the communication of public information officer dated 8th May 2025.

4-Most respected sir, at present, the Lucknow Development Authority, whether it may be an application on the Jansunwai portal or a complaint or any request, is ignoring everyone on the ground that a committee has been constituted in the matter, but neither will they tell anything about the committee nor will they try to solve the case in question, they have been adopted dilly-dallying approach in the matter for four years. Whether the Yogi government stops corruption in this way. They denied the information in the name of setting up a committee to look into the corrupt activities carried out by the concerned staff of the Lucknow Development Authority.

5- Right to information act 2005 was introduced by the government of India to promote transparency and accountability in the working of the public authorities. Whether in this way this August act will achieve its goal.

कृपया आप द्वारा सूचना का अधिकार अधिनियम 2005 के अन्तर्गत प्रस्तुत आवेदन के सापेक्ष मा0 राज्य सूचना आयोग में योजित अपील संख्या-10/ए/1318/2024 दिनांक 28.12.2024 का सन्दर्भ ग्रहण करने का कष्ट करें, जो कानपुर रोड योजना के अन्तर्गत भूखण्ड संख्या-एस0एस0-1914, 1915, 1916, 1917 एवं 1918 के अनियमित आवंटन/निबंधन से सम्बन्धित है।

उक्त के सम्बन्ध में सूचित करना है कि प्रश्नगत प्रकरण में समिति गठित करते हुए निम्नानुसार आवश्यक कार्यवाही की जा रही है। समिति के निर्देशानुसार स्थलीय आख्या प्राप्त करते हुए सम्बन्धित भूखण्डों के आवंटियों एवं शिकायतकर्ता को अभिलेखों/साक्ष्यों सहित कार्यालय में उपस्थित होने हेतु कई बार पत्र प्रेषित किये गये तथा दूरभाष पर भी वार्ता की गयी है। दोनों पक्षों द्वारा वांछित मूल अभिलेखों/साक्ष्यों सहित कार्यालय में उपस्थित नहीं हो रहे हैं, मात्र आवेदन पत्र प्रस्तुत है, जिस कारण प्रश्नगत प्रकरण के निस्तारण हेतु गठित समिति के निर्णय के सम्बन्ध में अग्रिम कार्यवाही नहीं हो पा रही है। इस सम्बन्ध में दोनों पक्षों को गठित समिति के समक्ष मूल अभिलेखों सहित उपस्थित होने हेतु विभिन्न पत्रों के माध्यम से सूचना प्रेषित की जा चुकी है। गठित समिति के समक्ष दोनों पक्षों के द्वारा वांछित मूल अभिलेखों/साक्ष्यों सहित कार्यालय में उपलब्ध होने के पश्चात नियमानुसार अग्रिम कार्यवाही की जायेगी। इस सम्बन्ध में वस्तुस्थिति से पूर्व में भी अवगत कराया जा चुका है।
