Subject- Tehsildar Lal Ganj is not provided information even after the repeated notice of the Uttar Pradesh information commission.

Short submissions of the appellant are as follows.

1-The appellant sought the following information from the public information officer as follows.

1- Most respected sir the grievance submitted on the public grievance portal concerns the working of the station house officer Drummond Ganj. The 3rd, 4th and 5th offenders are 3- Lekhpal, Lalganj tehsil, 4- Revenue inspector, Lalganj tehsil and 5- Tehsildar, Lalganj tehsil.

Please provide the name and designation of the public staff who authorized you/tehsil Lalganj to submit the report in the matter concerning the jurisdiction of the police station Drummond Ganj.

2- Please provide the reason how, you have reached this conclusion that the matter concerns to carry out inheritance because the information seeker did not request anywhere in the grievance for inheritance.

3- The information seeker has requested in the grievance that a first information report must be registered against five offenders who are indulged in cheating the properties of the information seeker by concealing the facts and overlooking the provisions of law through forgery.

Please provide the provisions of law which entitles Lekhpal, Revenue Inspector and Tehsildar Lal Ganj to entertain such application/grievances.

4- Please provide the name and designation of the public staff who forwarded the aforementioned grievance to tehsil Lalganj District Mirzapur.

5- Please provide the provisions of law which enables Lekhpal, Revenue Inspector and tehsildar Lalganj to entertain complaint concerning irregularities and corruption against them.

5- It is also noticeable that my grandfather died 5 years later than my father, so the applicant itself was class-1 heir in the matter, so this inheritance had to be conducted from my grandfather to the applicant not from my father to the applicant. This matter concerns the irregularities committed in processing the inheritance from my grandfather to his sons and the applicant was arbitrarily deprived by making a mockery of the law of land and provisions of revenue court 2006 was overlooked. The applicant was merely 10 years old during the processing of inheritance from grandfather to next heirs.

The name of the applicant was omitted from the list of heirs by colluding with the staff of Tehsil Sadar through bribes obvious from circumstantial evidence.

The matter concerns the deep-rooted corruption in the working of the public authority which is the root cause of public information officer is running providing information to the appellant.
