**The most surprising thing is that in the appeal, first appellate authority submitted a Misleading reply which is the mockery of the law.**

3-The appellant sought following information from the public information officer as follows.

**Sought information-1- Please provide the action taken report on the representation of Raj Kumar Gupta and Anarkali attached as the first page of the PDF document to this RTI application.**

**2- Right to reason is an indispensable part of the sound administrative system so please provide the reason for not taking witness testimony of Anarkali and Rajkumar Gupta who are prime victims in the matter and whose signature was taken forcibly by the land grabbers colluded with the Lekhpal and concerned chowki in-charge.**

- 3- Please provide the name and designation of the investigation officer of the police who is investigating the representation after Anarkali and Rajkumar Gupta attached as the first page of the pdf document.
- 4- Please provide the section of the criminal procedure code which is known as Indian citizens security code presently under which investigation officer is investigating the representation of Anarkali and Raj Kumar Gupta.
- 5- Please provide the right of the Kanhaiya for using the land which does not concern with him if he has any right then provide those documents.
- 6- Please provide the reason of not implicating any of the land grabbers under the criminal procedure code that is Indian citizens security code 107/116 i.e.126/135 while the applicant who is living at 35-kilometre distance and his mother were implicated in the apprehension of breach of peace by the police working in Nexus with the land grabbers.

7- Public information officer sir, you have carried out a confidential investigation in the matter through a police officer, now findings have reached to you so please provide the name and designation of that police officer.

- 4- Most respected sir/madam, Public information officer In the office of senior superintendent of police Mirzapur denied information as follows.

Reason for Rejection: - Section 8(1)(j).

- 5- Most respected Sir, whatever information has been sought by the information seeker concerns with the working of the police and Department of police is a public authority and right to information act 2005 has been introduced by the government of India to promote transparency and accountability in the working of the public authorities so it is an obligatory

duty of the public information officer to provide the information to the information seeker which means appellant. This investigation has been carried out on the application of the appellant, so the appellant has the right to make inquiry about the fairness of the investigation carried out by the personnel of the department or police.

6- Most respected Sir/Madam, Public information officer In the office of superintendent of police provided the seven pints of information as follows. **Provided information 1- In relation to the information sought in reference to the above point, a copy of the investigation report conducted by S.I. Shriram Singh, In charge Outpost Dubar Kala, Police Station Lalganj, Mirzapur is enclosed.**

Submission-The appellant is seeking action taken report on the representation of Raj Kumar Gupta and Anarkali attached as the first page of the PDF document to this RTI application.

Representation of Raj Kumar Gupta and Anarkali is addressed to S. P. Mirzapur.

Whether the victims were contacted by the concerned investigation officer appointed by the superintendent of police.

Attached report is the justification of bogus agreement under pressure of offenders.

**The information of the public information officer under this point is misleading.**

**Provided information 2- Regarding the information sought in reference to the above point, on the basis of the report received from S..I Shriram Singh, Incharge Outpost Dubar Kala Police Station Lalganj Mirzapur, a copy of the investigation report sent by me, the Circle Officer on 01.05.2025 along with the record is enclosed.**

Submission- The information under this point is also misleading. The appellant is seeking reason of not taking witness testimony of the victims which was the essential component of investigation. Due to corruption, police did not take any action on the representation of Raj Kumar Gupta and

Anarkali and now trying to mislead as usual practice of police.

**Provided information 3-Regarding the information sought in reference to the above point, the information has been provided by S.I. Shriram Singh, Incharge Outpost Dubar Kala, Police. Station Lalganj, Mirzapur.**

Submission-No investigation has been carried out on the representation of Raj Kumar Gupta and Anarkali and report attached is a forgery of the police to mislead not only appellant but also commission. Please information commission may order an enquiry into the matter and the appellant will prove that this is part of the report submitted by concerned S.I. on the Jansunwai portal on the complaint of applicant and its upper portion has been removed to mislead. Because in the Upper portion, there is description of the complainant and the investigation officer in such a reports submitted on the Jansunwai portal by the police.

**Provided information 4- Since the matter is a land dispute between both the parties, the investigation is under the Revenue Department.**

Submission-Misleading information. Actually representation of victims never investigated by police. How will they tell under which section of BNSS they are investigating the representation of the victims/senior citizens?

**Provided information 5- Since the matter is a land dispute between both the parties, the investigation is under the Revenue Department.**

Submission- Please provide the rights of Kanhaiya who the tools in the hand of land mafia is having nexus with police and revenue staff ipso facto. How can Kanhaiya be the party in the matter? Police made available misleading information under this point.

**Provided information 6- In view of the land dispute between the two parties and the tension/peace prevailing between the two parties, preventive action has been taken by the local police under section 126/135 BNSS.**

Submission-PIO did not provide reason. There is specific jurisdiction of police stations and police outposts and this section of BNSS confines to people living in that jurisdiction. The applicant and her mother do not live at that place obvious from the address.

**Provided information 7-In reference to the above point, the Additional Superintendent of Police, Operation Mirzapur, has investigated and sent the report on 25.03.2025.**

**Submission- Where is the name and designation of that officer who carried out Investigation under the monitoring of Additional superintendent of police?**

**This point of information is also misleading.**

This is a humble request of your appellant to you Hon'ble Sir that how can it be justified to withhold public services arbitrarily and promote anarchy, lawlessness, and chaos arbitrarily by making the mockery of law of land? There is need of the hour to take harsh steps against the wrongdoer to win the confidence of citizenry and strengthen the democratic values for healthy and prosperous democracy. For this, your appellant shall ever pray for you, Hon'ble Sir.
