Short submissions of the applicant are as follows.

1-The matter concerns the working of the additional principal judge family court second registered as criminal miscellaneous cases 915/2021. During the pendency adjudication, my father is selling the movable and immovable properties of the family inherited from the ancestors which is illegal and unconstitutional.

2-My marriage was a traditional Hindu marriage in which the bridegroom is like a puppet and he only follows the dictates of his father.

The applicant has given several grievances to stop him from selling the family properties, but the applicant failed to stop him. The following grievances are being processed by public staff in Mirzapur District.

3-If a property is sold before a court verdict to avoid payment, it may be considered fraudulent conveyance or an attempt to evade legal obligations. In India, courts can intervene if they find that the sale was made to defeat a judgment or avoid financial liability.

The attempt of my father is an attempt to defeat the judgement awaited from the pending adjudication in the aforementioned case filed by my wife for securing justice.

4- Entire dowry and ornaments taken from the father in-law by my father not by the applicant but why the applicant is being tortured and harassed is unnatural and against the law.

5- When the father is continually selling the ancestral properties then from where maintenance and other demands will be fulfilled if the court orders so. Therefore no property must be sold without taking permission from the court of law.

6- Police must charge my father and younger brother under the sections of cheating of Bhartiya Nyaya Sanghita.

7-Most respected Sir, Aadhar card of the applicant is also attached to the grievance which must be perused by the most respected sir.

8-Think about the ulterior motive of my father that he is declaring his own son as a lunatic without the findings of a medical expert while the applicant is educated and graduate in commerce.

This is a humble request of the applicant to the most respected sir to direct the concerned police personnel to take proper action against my father and younger brother for usurpation through cheating of the ancestral properties which are the shares of the applicant and his family members.
