Subject: Request for Action Against Police Personnel for Wilful Disobedience of Civil Court Orders and Misleading Reports

Respected Sir,

I, Ashok Kumar Maurya, a resident of Village Bihasara Khurd, Post Bihasara, District Mirzapur, Uttar Pradesh – 231303, humbly submit this representation seeking your urgent intervention in a matter of grave concern involving the violation of a civil court order and the apparent misconduct of police personnel under the jurisdiction of the Senior Superintendent of Police, Mirzapur.

1. Background of the Grievance

The grievance registered under number GOVUP/E/2025/0068150 on 20/06/2025 concerns the non-compliance of a civil court order by local police authorities. The court had clearly directed the maintenance of status quo in a property-related matter. However, the Station House Officer of Jigna Police Station allowed unauthorized construction of drainage and the opening of a door in the disputed area, thereby violating the court's directive.

2. Pattern of Misleading Reports

It is deeply troubling that the Senior Superintendent of Police, Mirzapur, has submitted inconsistent and arbitrary reports on multiple occasions—specifically on 2nd May 2025, 4th June 2025, and 14th July 2025. These reports fail to address the core issue and reflect a lack of understanding or deliberate negligence regarding the court's order.

This raises serious questions about the competency and integrity of the personnel involved. Repeated submission of misleading reports not only undermines the judicial process but also erodes public trust in law enforcement.

3. Evidence of Corruption and Negligence

The following points highlight circumstantial evidence of corruption:

Unauthorized construction and door installation in the impugned area despite court orders.

Inaction by police personnel even after being informed of the violations.

Two sub-inspectors caught red-handed by the vigilance team, indicating systemic corruption.

Such actions suggest that the offenders acted in good faith with the police, possibly through corrupt means, and the SSP Mirzapur is well aware of these developments.

4. Legal Implications

The conduct of the SSP Mirzapur may attract penal provisions under the Indian Penal Code:

Section 182 IPC – Knowingly providing false information to a public servant: punishable with up to 6 months

imprisonment or ₹1,000 fine or both.

Section 177 IPC – Furnishing false information not related to a criminal offense: punishable with up to 6 months or ₹1,000 fine.

Section 211 IPC – False accusation of a serious offense: punishable with up to 7 years imprisonment and fine.

5. Appeal for Justice

The failure of the police to enforce the court's order and the submission of misleading reports reflect anarchy and corruption in the system. It is imperative to ensure that:

Competent personnel are appointed who can understand and act upon the grievances of the public.

Strict action is taken against those who violate court orders and mislead the government.

Accountability mechanisms are strengthened to prevent recurrence of such incidents.

Conclusion

With utmost respect, I request your kind attention and intervention to uphold the rule of law and ensure justice. I place my faith in your leadership and the commitment of your office to protect the rights of citizens and maintain the sanctity of judicial orders.
