Subject:

Non-compliance with RTI Act provisions by the Public Information Officer despite notice; prayer for penal and disciplinary action under Section 20 of the RTI Act, 2005.

Background and Chronology:

- RTI Application Filed:** 04/11/2024
- First Appeal Filed:** 07/12/2024 (No response received from PIO within 30 days, violating Section 7(1) of the RTI Act)
- Second Appeal Registered:** 17/01/2025
- Notice Issued by Commission:** 07/08/2025 for hearing on 14/08/2025
- Hearing on 14/08/2025:** Both parties absent; Commission directed issuance of fresh notice for hearing on 29/09/2025.

Legal Violations:

Section 7(1): PIO failed to respond within 30 days.

Section 19(1): FAA failed to act on the first appeal.

Section 19(3): Grounds for second appeal established due to inaction and denial of information.

Information Sought (Summarized):

- Action taken on the complaint of Shri Jaichand Maurya against Dr. Pradeep Kumar.
- Action against CMO Prayagraj and CMS Bhadohi for non-cooperation in investigation.
- Tenure details of Dr. A.K. Shrivastava as Joint Director and Additional Director.
- Copies of communications between the department and the State Information Commission regarding closure of earlier appeal (A-20240901687).
- Tenure of Joint Director Dr A K Shrivastava as Joint director, DG Karmik including initial date and final date of posting. Also, provide the tenure of Joint Director Dr A K Shrivastava as additional director, director, DG Karmik including initial date and final date of posting.

Broader Concerns:

Transparency Deficit: Despite 19 years of RTI implementation, systemic non-compliance persists.

Corruption Shielding: Bureaucratic apathy is undermining the RTI framework.

Human Rights Ignored: Medical negligence and departmental misconduct are not being addressed.

Prayer to the Commission:

In light of the above, the appellant respectfully prays that the Hon'ble Commission may be pleased to:

1. **Invoke Section 20(1)** of the RTI Act and impose penalty on the PIO for willful denial of information.
 2. **Recommend disciplinary action** against the First Appellate Authority under Section 20(2) for deliberate inaction.
 3. **Direct the PIO** to furnish the complete information sought, along with proof of dispatch to the appellant.
 4. **Ensure compliance** with the spirit and letter of the RTI Act to uphold transparency and accountability in public administration.
