Subject: Submission regarding the typographical error in the district name (Mirzapur instead of Shahjahanpur) and the persistent failure of the Public Information Officer to provide the requested information in Case No. A-20250102076.

Most Respected Sir,

The present appeal arises from the gross inaction of the Public Information Officer (PIO) and recurring clerical errors in the official orders issued by the Commission. The appellant humbly submits the following points for your kind consideration and necessary action.

1. Procedural Irregularity and Typographical Error:

It is most respectfully submitted that the honourable Commission has consistently and erroneously mentioned "Shahjahanpur" instead of "Mirzapur" as the district of the PIO in two separate orders. This is a crucial procedural irregularity that has likely caused confusion and may have prevented the PIO from receiving the summons correctly.

- In the order dated 27.06.2025 (Appeal No. S-08-0554/A/2025), the district was wrongly stated as "Shahjahanpur."
- Subsequently, in the order dated 18.08.2025 (Appeal No. S-08/A/0554/2025), the same mistake was repeated.

This recurring error is a matter of record and needs immediate rectification to ensure that the proceedings can continue effectively and that the notices are delivered to the correct official at the appropriate address.

2. Non-Compliance with the RTI Act, 2005:

Furthermore, and more critically, despite the Commission's explicit directive in the order dated 27.06.2025, the Public Information Officer has failed to provide any information whatsoever. The said order specifically directed the PIO to:

"...certify the point wise information in the form of the appellant and send it through post to the known address of the appellant within next 15 days..."

The PIO's failure to comply with this order is a direct violation of their duty under the RTI Act, 2005, and represents a clear act of defiance of the Commission's authority. This non-compliance is a serious matter, as it undermines the very purpose of the Act and the right of a citizen to obtain information.

3. Points of Information Denied:

For the record and for the honourable Commission's immediate reference, the appellant sought the following five points of information, which have been consistently denied by the PIO:

1. Notings made on the communication sent by Lalji, Senior Operations Manager, Indian Oil Corporation Limited, Pipelines Division, Eastern Region Pipelines, Subedar Ganj, Prayagraj.
2. A copy of the communications made in this matter by the Ministry of Petroleum and Natural Gas with the Sub-Divisional Magistrate, Sadar, District Mirzapur.
3. The action taken report on the communications of the Ministry of Petroleum and Natural Gas with the Sub-Divisional Magistrate, Sadar, District Mirzapur.
4. The names and designations of the staff of Tehsil Sadar who are processing the communications of the Ministry of Petroleum and Natural Gas in this matter.
5. The reason for new constructions taking place in the danger zone and the reason for not taking any action on the communications of the Ministry of Petroleum and Natural Gas.

Prayer:

In light of the aforementioned submissions, the appellant, in the interest of justice, humbly and respectfully prays that the Honourable Commission may be pleased to:

a) Direct the immediate and formal correction of the typographical error in all records from "District-Shahjahanpur" to "**District-Mirzapur.**" b) Initiate punitive proceedings under Section 20 of the RTI Act, 2005, against the Public Information Officer for the repeated failure to comply with the Commission's orders. c) Issue a fresh and stern directive to the Public Information Officer to provide all the requested information, certified and in a time-bound manner, without any further delay.

The appellant will be eternally grateful for your timely intervention in this matter.
