<b>Incident Details:</b>	<p>BEFORE THE HON'BLE CHAIRPERSON AND MEMBERSUTTAR PRADESH STATE HUMAN RIGHTS COMMISSION (UPSHRC)27/1, Gokhale Marg, Lucknow – 226001 COMPLAINT UNDER THE PROTECTION OF HUMAN RIGHTS ACT, 1993 Subject: Complaint against Shri Vivek Jawla (Circle Officer, City, Mirzapur) and associated personnel for gross negligence, suppression of evidence, and filing a biased Investigation Report dated 29/11/2025.Ref: Grievance Registration Nos: PMOPG/E/2025/0177329 and GOVUP/E/2025/0136498. Respected Chairperson and Hon'ble Members, I, Archana Devi, W/o Shri Amit Kumar Dubey, resident of Gharhu Patti, P.S. City Kotwali, District Mirzapur, submit this representation regarding the blatant violation of my fundamental and human rights by the Mirzapur Police. 1. Facts of the Incident: On October 24, 2025, a daylight robbery and house-breaking occurred at my residence. Despite being a cognizable offense involving the theft of jewelry worth ₹8 lakh and household goods, the local police failed to intervene or register an FIR. 2. Objection to the Report dated 29/11/2025: The Circle Officer (City), Shri Vivek Jawla, submitted an investigation report letter No: COC-IGRS/2025 dated November 29, 2025. I strongly object to this report on the following grounds: Misclassification of Crime: The report erroneously characterizes a violent criminal act (House-breaking/Robbery) as a mere "ancestral property dispute" to avoid the mandatory registration of an FIR. Suppression of Direct Evidence: The report is silent on the fact that a Police Constable from Fataha Chowki was present and made a videography of the incident. By ignoring this video, the CO has protected the accused. Contempt of Supreme Court Mandate: The report dated 29/11/2025 violates the law laid down in Lalita Kumari vs. Govt. of U.P., which removes police discretion in registering FIRs for cognizable offenses. 3. Prayer to the Hon'ble Commission: I humbly pray that this Hon'ble Commission: Summon the report dated 29/11/2025 and the associated video evidence for a high-level review. Initiate an inquiry into the conduct of CO Vivek Jawla for shielding the accused and depriving the applicant of the "Equal Protection of Law." Direct the registration of a First Information Report (FIR) against the offenders at P.S. City Kotwali.
