1. Facts of Inaction: The Appellant filed an RTI on 14-08-2025. Despite the lapse of over 120 days, the PIO (Tehsildar Sadar) has not provided any information. The First Appellate Authority (SDM Sadar) also failed to pass any order. This is a deliberate attempt to suppress information.

2. Urgency & Property Dispute: The information requested (Official contact details and revenue records) is critical. The Appellant's father is currently selling ancestral properties without partition and is attempting to declare the Appellant as "mentally unstable" to grab his share. The PIO's silence is aiding this illegal activity.

3. Specific Information Requested (Emails): The Appellant specifically seeks the certified official contact information for the following offices to serve legal notices:

- **SDM Sadar, Mirzapur (First Appellate Authority):** sdm-sadar.mi@up.gov.in
- **Tehsildar Sadar, Mirzapur (PIO):** teh-sadar.mi@up.gov.in (Alternative: tehalganj.mi@up.gov.in as per current portal records).

4. Prayers to the Commission:

- **Direct the PIO** to provide the requested information and certified land records immediately and free of cost.
- **Impose Penalty:** Under Section 20(1) of the RTI Act, impose a penalty of **₹250/day (Max ₹25,000)** on the PIO, Shri Vishal Kumar Sharma, for "Deemed Refusal."
- **Disciplinary Action:** Recommend a departmental inquiry into why the PIO "did not entertain" the application.
