(Respondent)**Subject: Urgent Objection to the False and Misleading Reply of the Respondent PIO and Representation for Initiation of Contempt Proceedings for Perjury.****Most Respectfully Showeth:**

- That the Appellant has been consistently pursuing the requested information, which pertains to vital public records, for over a year, despite repeated directions from this Hon'ble Commission.
- That the Respondent PIO, Ms. Diksha, Tehsildar Lalganj, in her official reply pertaining to the RTI application (Registration No. DMOMR/R/2024/60070, Date of Filing: 21/07/2024), has officially stated:

Reply: "आवेदिका साधना तिवारी को सूचना दी जा चकी है।" (Information has been supplied to the applicant, Sadhana Tiwari.)

3. **Crucially, this specific reply is recorded in the RTI online status details provided by the Appellant.** (Refer to the excerpt provided: **Registration Number DMOMR/R/2024/60070** under the "Reply" section.)
4. That this statement made by the PIO is **patently false and amounts to Perjury and a deliberate misrepresentation** to evade her statutory duty and mislead this Hon'ble Commission.
5. That upon contacting Ms. Sadhana Tiwari, the supposed recipient of the information (whose name appears in the official reply), she categorically denied receiving any information whatsoever from the Tehsildar's office.
6. Ms. Tiwari specifically stated to the Appellant: **"She is telling a lie. She has not made available any information to her. Sadhana Tiwari also said that she must "Maintain the dignity of her post."**
7. This conduct proves that the PIO is not only **willfully disobeying the orders of this Hon'ble Commission** (as detailed in the representation dated 04/10/2025) but is also actively **fabricating official records and making false claims** in a judicial proceeding to cover up her non-compliance.
8. The PIO's actions demonstrate a clear lack of integrity, gross misuse of her official position, and utter **Contempt of Court/Commission** by making a false statement on record. This warrants the most stringent action under the RTI Act and other applicable laws.
9. The Appellant's original plea for the release of information and imposition of penalties under Section 20(1) is further strengthened by this verifiable act of official dishonesty.

PRAYER

In light of this newly discovered evidence of a false claim by the PIO, it is most respectfully prayed that this Hon'ble Commission may be pleased to:

- (a) Take immediate judicial notice of the PIO's false statement (Perjury) made in the official RTI reply (Registration No. DMOMR/R/2024/60070) and her continuous, willful disobedience (Contempt of Commission).
- (b) Issue a Show Cause Notice to Ms. Diksha, Tehsildar Lalganj, for making a false official statement to the Commission and direct her to prove the delivery of information to Ms. Sadhana Tiwari with valid acknowledgment/proof.
- (c) Initiate the maximum penalty proceedings under Section 20(1) of the RTI Act, 2005, for her deliberate delay, continuous non-compliance, and the additional charge of misrepresentation/perjury.
- (d) Pass any other order or direction that this Hon'ble Commission deems fit and proper to uphold the dignity of its proceedings and secure justice for the Appellant.
