I wish to bring to your immediate attention a serious and systematic denial of information under the RTI Act, 2005, through **five (5)** identical requests filed with the

Tehsildar, Lalganj. The PIO, Tehsildar Diksha, has recorded a false claim of compliance, while the First Appellate Authority (SDM Lalganj) has failed to perform their statutory duty.

2. Details of RTI Requests and False Compliance

The following five RTI applications, filed by me, have been falsely marked as **"REQUEST DISPOSED OF"** with the standardized and non-specific remark: आवेदक को सूचना प्राप्त हो चुकी है (The applicant has received the information).

The PIO's Claim is False (Proof):

- **No Information Received:** I emphatically state that I have **NOT** received the requested information for any of the above requests.
- **No Documents Uploaded:** The RTI portal confirms that **no documents or reply have been uploaded** by the PIO, Tehsildar Lalganj, to substantiate the claim of disposal.
- **Second Appeal Pending:** My **Second Appeal** against the denial of information is currently **pending before the Uttar Pradesh Information Commission (UPIC)**, which is definitive proof that the claim of receipt of information is fabricated.

3. Failure of First Appellate Authority (FAA)

The statutory duty of the FAA is to hear and decide the First Appeal within **30 days** of its filing.

- I was compelled to file First Appeals in all these cases after the PIO either failed to reply or provided a delayed/unsatisfactory reply.
- The **Sub-Divisional Magistrate (SDM), Lalganj, who is the designated FAA**, has **still not entertained, heard, or decided** the First Appeals for any of these five RTI matters.
- This failure by the SDM, Lalganj, constitutes a **gross violation of Section 19(1)** of the RTI Act and demonstrates a complete breakdown of the first stage of the appellate mechanism in the Subdivision.

4. Prayer for Immediate Action

In light of the above deliberate and systematic denial of information, I request the respective competent authorities to take the following urgent action:

1. To the Hon'ble Chief Information Commissioner and IC Shakuntala Gautam:

- Treat this representation as supplementary evidence for my pending Second Appeal(s).
- Initiate immediate action under **Section 20(1)** of the RTI Act against the PIO, Tehsildar Diksha, for **willfully denying information** and recording **false compliance**.
- Impose the statutory penalty on the PIO.

2. To the CM, Governor, Chief Secretary, and SDM Lalganj:

- Direct the SDM, Lalganj, to immediately provide the status of the First Appeals and furnish the records of all hearings conducted, if any.
- Initiate an inquiry against the PIO, Tehsildar Diksha, for using the cryptic note (आवेदक को सूचना प्राप्त हो चुकी है) to fraudulently close multiple cases and against the SDM, Lalganj, for dereliction of duty as the FAA.
- Ensure that the complete, correct, and certified information is provided to me forthwith.

I look forward to your immediate intervention to safeguard the principles of transparency and accountability under the RTI Act.
