## 1. PARTICULARS OF THE RTI APPLICATION

- **RTI Registration No:** SPMZR/R/2025/60241.
- **Date of Filing RTI:** 08/09/2025.
- **Date of PIO Reply:** 14/10/2025 (Received after the 30-day statutory limit).
- **Date of First Appeal Filing:** 10/10/2025.
- **Date of FAA Order:** 15/11/2025.

## 2. BRIEF STATEMENT OF FACTS

1. The Appellant sought five points of administrative information regarding the handling of a **UPHRC order** dated 27/08/2025.
2. The Appellant specifically requested the **Certified copies of the communication/covering letter** sent to the UPHRC (Point 2) and **Names/Designations** of the processing staff (Points 1 & 5).
3. The PIO initially refused the information, claiming the investigation was "in progress".
4. The FAA subsequently provided an internal **Inquiry Report (Janch Akhya)** dated 19/10/2025 but did not provide the actual communication records.

## 3. GROUNDS FOR SECOND APPEAL

- **Mismatched Information:** The Respondents provided an internal **Inquiry Report** addressed from a subordinate to a superior. This is **not** the official "Communication" or "Forwarding Letter" addressed to the Secretary, UPHRC, as requested.

- **Willful Suppression of Dispatch Records:** An official **Covering Letter** with a **Dispatch/Patrank Number** exists. Withholding this in the RTI response is a violation of the Act.
- **Suppression of File Notings:** No **Certified Copies of File Notings** were provided despite being explicitly requested.
- **Non-Disclosure of Staff Details:** The names of staff who handled the UPHRC order have been withheld without legal cause.


#### 4. PRAYER / RELIEF SOUGHT

The Appellant humbly prays that the Hon'ble Commission may:

1. Direct the PIO to provide the **Certified Copy of the Forwarding Letter** addressed to the Secretary, UPHRC, with **Dispatch Details**.
2. Direct the PIO to provide **Certified Copies of the File Notings**.
3. Impose a **Penalty** on the PIO under Section 20(1) for the delay and misleading response.
