RTI RULES, 2015Most Respectfully Showeth: That the present appeal was filed seeking critical information regarding staff postings and the implementation of the New Transfer Policy in Tehsil Sadar, Mirzapur. That on 02.09.2025, this Hon'ble Court passed an order disposing of the appeal and consigning the file to the records on the grounds of "lack of interest" due to the non-attendance of the appellant.That the appellant submits that the absence was neither intentional nor deliberate but was due to [mention reason: e.g., technical failure of the link / non-receipt of timely email notification].That the Hon'ble Commission itself noted in the order dated 30.04.2025 and 02.09.2025 that the Public Information Officer (PIO) has consistently failed to appear and has willfully disobeyed the Commission's prior directives to provide the information.That the PIO's defiance constitutes a grave violation of the RTI Act 2005. Closing the file without ensuring information disclosure rewards the PIO's non-compliance and defeats the very purpose of the Act.That the appellant is deeply interested in the matter and has already submitted a Knowledge of Fact (K.O.F.) document under Diary Number D-240120260001 to prove continued pursuit of the case. PRAYER It is, therefore, most humbly prayed that this Hon'ble Court may be pleased to:Recall the order dated 02.09.2025 and restore the appeal to its original number in the interest of justice. Direct the PIO (Tahsildar Sadar) to provide the 4-point information sought immediately.Initiate penalty proceedings under Section 20(1) against the PIO for continuous defiance of this Court's orders. **To, The Chief State Information Commissioner, Uttar Pradesh Information Commission, RTI Bhawan, Vibhuti Khand, Gomti Nagar, Lucknow.****Subject: Formal Complaint regarding the evasion of the PIO (Tehsildar Sadar, Mirzapur) and Request for Review of Closure Order in Appeal No. S-09/A/1963/2024.****Respected Sir,**

I am constrained to bring to your urgent attention a serious miscarriage of the Right to Information Act, 2005, occurring in the court of State Information Commissioner (S-9).

**1. The Gravity of PIO Defiance:** In the matter of *Yogi M.P. Singh vs. PIO, Office of Tehsildar Sadar, Mirzapur*, the PIO has shown a continuous and wilful disregard for the Commission's authority. Despite several notices (dated 04.02.2025, 18.03.2025, 20.03.2025, 24.04.2025, 03.07.2025, and 28.08.2025), the PIO failed to appear or provide the requested information.

**2. Failure of Administrative Compulsion:** The Information Commission is vested with the powers of a Civil Court to enforce the attendance of public servants. However, in this case, the PIO—a public servant—successfully "ran away" from his legal obligations by simply remaining absent until the case was dismissed.

**3. Improper Closure of File:** The order dated 02.09.2025 disposed of the appeal on the grounds of "lack of interest" by the appellant due to non-attendance. I submit that the Commission's primary duty is to ensure the disclosure of information and punish the PIO for non-compliance, regardless of the appellant's presence, especially when the PIO's default is already a matter of record.

**4. Prayer:** I humbly request your office to:

- **Set aside the closure order** dated 02.09.2025.
- **Summon the PIO (Tehsildar Hemant Kumar)** through a bailable warrant or disciplinary recommendation to the District Magistrate to explain his repeated absences.
- **Impose the maximum penalty** under Section 20(1) for the deliberate withholding of posting and transfer details.

प्रस्तुत प्रकरण के संबंध में अपीलार्थी द्वारा सूचना का अधिकार अधिनियम, 2005 की धारा 6(1) के अन्तर्गत जनसूचना अधिकारी को दिये गये आवेदन-पत्र दिनांकित 08.08.2024 के माध्यम से 04 बिन्दुओं पर ऑनलाइन सूचना मांगी गई। वांछित सूचना न मिलने पर अपीलार्थी द्वारा सूचना का अधिकार अधिनियम, 2005 की धारा 19(1) के तहत दिनांक 18.09.2024 के पत्र द्वारा प्रथम अपीलीय अधिकारी के समक्ष ऑनलाइन प्रथम अपील प्रस्तुत की गयी। वांछित सूचना समयावधि में न मिलने व प्रथम अपील का निस्तारण न होने की स्थिति में अपीलार्थी द्वारा सूचना का अधिकार अधिनियम, 2005 की धारा 19(3) के तहत दिनांक 04.11.2024 को आयोग के समक्ष ऑनलाइन द्वितीय अपील की गई।

पत्रावली के अवलोकन से यह स्पष्ट होता है कि प्रकरण में वांछित सूचनायें अपीलार्थी को उपलब्ध कराये जाने हेतु आयोग द्वारा विभिन्न आदेशों के माध्यम से विपक्षी जनसूचना अधिकारी को स्पष्ट आदेश/निर्देश निर्गत किये जा चुके हैं। जबकि प्रकरण में अपना-अपना पक्ष प्रस्तुत करने हेतु उभयपक्ष आयोग के समक्ष निरंतर उपस्थित नहीं हुये हैं।

प्रकरण के सम्बन्ध में आयोग द्वारा क्रमशः दिनांक 04.02.2025, 18.03.2025, 20.03.2025, 24.04.2025, 03.07.2025 व 28.08.2025 को प्रेषित नोटिस व निरंतर लिंक प्रेषित किये जाने के क्रम में अपीलार्थी अपना पक्ष प्रस्तुत करने हेतु लगातार आयोग के समक्ष उपस्थित नहीं हुए हैं और न ही अपीलार्थी की ओर से कोई प्रत्यावेदन प्रेषित किया गया है। ऐसा प्रतीत होता है अपीलार्थी को अपने प्रकरण में कोई रुचि नहीं है।

उपरोक्त स्थिति में प्रकरण को गतिमान रखने का कोई औचित्य प्रतीत नहीं होता है एवं उक्त द्वितीय अपील निस्तारित किये जाने योग्य है। तदनुसार प्रस्तुत द्वितीय अपील अन्तिम रूप से निस्तारित की जाती है। पत्रावली दाखिल दफ्तर हो।

Subject- Tahsildar Sadar neither made available information nor provided any reason regarding the delay in providing information to the information seeker.

1-The appellant sought following 4 points information from the public information officer in the office of subdivisional magistrates Sadar district Mirzapur which was denied by him.

1- Provide the posting details of all the first class and second-class employees of the department, the date on which they started service in Mirzapur district and for how long they have been posted, where was their first posting.

2- Sir, please provide the posting details of all the third-class employees of the department and the details of the date of commencement of their service in the district and other posting related details, Sir, also provide that from which district they have come to Mirzapur after being transferred.

3- Sir, the posting details of all the class IV employees of the department posted in the district and the details of the date of commencement of service in the district and if they have been transferred from other districts to this district, then also provide the details of that.

4- Sir, please provide to the applicant whether the new transfer policy

issued by the state government is being followed in the department or not and if it is being followed, then how has it happened till date, with the step-by-step efforts taken in that direction, the applicant must be informed.

Order

The appeal registered through Complaint and Appeal Tracking System (CATS) was presented for hearing today. Notice was sent to both the parties through email on 24.04.2025 for the hearing on 30.04.2025 and a link was sent for the video conferencing hearing. The file was presented. The call was made. Both the parties were absent today.

On examining the file, it was found that while disposing of the application of the appellant on 21.03.2025, the Commission sent a notice through email on 24.04.2025, directing the opposite Public Information Officer to make the information available to the appellant before the due date and to present the written statement along with a copy of the information and evidence of dispatch before the Commission on the due date, but today on the date of hearing, the opposite Public Information Officer neither appeared in person nor presented his side through any representative.

In the above situation, giving an opportunity to the opposition Public Information Officer, Office of the Tehsildar, Tehsil-Sadar, District-Mirzapur, a notice should be sent by attaching a copy of the order passed today, that as per the rules and provisions of the Right to Information Act 2005 and Uttar Pradesh Right to Information Rules, 2015, the disposal of the application of the appellant should be made available to the appellant before the due date and a copy of the disposal report/information and a written statement along with sending the information should be made available to the Commission before the due date.

Notice should be sent to the appellant to present his side in the appeal. The hearing for the file should be held on 06.06.2025.
