Subject: Written Submission/Rejoinder - Appeal No: S05/A/0428/2024 (Hearing: 14/01/2026)

To the Hon'ble State Information Commissioner,

I, Yogi M. P. Singh (Appellant), am unable to attend the hearing in person today as I am currently in Mirzapur. I request the Commission to consider this written submission against the PIO's rejection dated 23/05/2025.

1. Illegal Rejection under Rule 4(2)(b)(ii):

The PIO (LDA) rejected my request claiming I sought "interpretations/opinions." This is factually incorrect. My request seeks specific Records as defined under Section 2(f) of the RTI Act:

- **Point 1 & 2:** I am asking for the **Names and Designations** of committee members. This is a matter of record, not an opinion.
- **Point 3:** I am asking for the **Timeframe** mentioned in the official order. This is a documented fact.
- **Point 5:** I am asking for the **Inward/Movement status** of a specific grievance. This is data, not advice.

2. Evidence of Concealment:

A letter from the LDA Property Officer dated 06/08/2021 already admitted the existence of this committee. By refusing to provide the members' names and progress reports now, the PIO is deliberately shielding irregularities in plot allocations and registries that have been pending for over 4 years.

3. Prayer:

- I request the Hon'ble Commission to set aside the PIO's rejection.
- Direct the PIO to provide certified copies of the documents requested within 7 days.
- Impose a penalty on the PIO under Section 20(1) for providing a misleading and baseless rejection to delay the disclosure of corruption-related information.

This application is on behalf of Dinesh Pratap Singh son of Angad Prasad Singh to seek information concerning deep irregularities in the working Lucknow Development Authority. Most respected Sir, please take a glance at the first page of the attached PDF document to this online RTI application which is the communication dated 6th August 2021 of the property officer of Lucknow development authority in respect of representation submitted by the information seeker. In this communication property officer Lucknow development authority disclosed that Lucknow development authority is seeking documents from the allottees in the matter as well as our committee has been set up by the competent authority of the Lucknow development authority to make inquiry into the matter of irregularities in executing registry of the impugned land as well as irregularities in the allocation of the plots by Lucknow development authority. Public information officer, Lucknow development authority may provide the following information to the information seeker point wise as follows.

- 1- Please provide the name and designation with posting details of the competent officer who has set up the committee to look into the irregularities in committing execution of registry and the allotment of the plots.
- 2- Please provide the name and designation of the members of the committee who were appointed by the competent authority as well as their posting details.
- 3- Please provide the span of time given to the committee to complete the enquiry into the matter of irregularity, if not given then please provide the maximum time whatever will be given to the committee to complete the inquiry. It is quite obvious that two years and four months have passed but the committee could not complete the inquiry.
- 4- For five years Lucknow development authority has been seeking documents from the allottees of the plots, Please provide the reason for not taking any action against them as right to reason is the indispensable part of the sound administrative system quoted by the apex court of India in its various judgments.
- 5-Dinesh Pratap Singh submitted a document of 20 pages before a committee set up for looking for anomalies in allocation plots by L.D.A. Details are as follows.

Public information officer must provide these 5-points information to the information seeker within a stipulated 30 days as prescribed under subsection 1 of section 7 of the right to Information Act 2005.
