- 1. Non-Compliance with RTI Points:** The Appellant submits that the response dated 14.01.2026 provided by the PIO/Tehsildar Sadar is incomplete and misleading. The PIO has merely provided the status of a court case (T202216530107209) instead of answering the **5 specific points** regarding administrative accountability and the handling of grievance No. 60000250091069.
- 2. Failure to Address Administrative Lapses:** The RTI application specifically sought the name and designation of officials in the Chief Minister's Office and the Home Department who wrongly classified a revenue matter as a "police matter". The PIO's response is silent on these points, which constitutes a **deemed refusal** of information.
- 3. Contradiction in Revenue Records:** The PIO's response states the court case was dismissed on 13.10.2025 for "lack of interest". However, internal records show that as of 02.09.2025, the **Lekhpal of Village Babura had failed to submit the partition (Faat) report** for over a year, despite a court order dated 13.09.2024. The administrative delay by the Lekhpal effectively stalled the case, yet no information has been provided regarding action taken against this negligent official.
- 4. Inordinate Delay:** The original RTI was filed on 03.06.2025. The PIO provided the current unsatisfactory response only on 14.01.2026, after a delay of over **7 months** and only after the Hon'ble Commission issued a Show Cause Notice.

PRAYER

In light of the above, the Appellant humbly prays that this Hon'ble Commission may:

- **Direct the PIO** to provide point-wise, specific answers to all 5 points of the RTI application immediately.
- **Impose a Penalty** of ₹25,000 on the PIO under Section 20(1) of the RTI Act for the intentional delay and for providing evasive information.
- **Recommend Disciplinary Action** against the concerned Lekhpal and the PIO for suppressing information regarding the non-compliance of judicial orders.





Name of the applicant-Yogi M. P. Singh Subject-Most respected Sir, tehsildar Sadar submitted an arbitrary and inconsistent report in the following grievance which is reflecting jungle raj in the working of the tehsildar Sadar Mirzapur. Think about the gravity of the situation: an order has been passed by the Additional officer Sadar Mirzapur which compliance had to be made by the Lekhpal Babura Chhanvey Mirzapur and the Lekhpal is telling in his report about the serial number of the case. It is obvious that public complaints section after Chief Minister Office endorsed the matter to the district magistrate Mirzapur for action in accordance with the law on 29th April 2025. District Magistrate submitted her report through the circle officer city Mirzapur which was accepted by the staff of the Chief Minister Office. Public information officer in the office of Chief Minister Govt of Uttar Pradesh must provide the following information pointwise as follows. 1- Right to reason is an indispensable part of the sound administrative system. Please provide the name and designation of the staff of the government of Uttar Pradesh who reached to the conclusion that the matter concerns the working of the police. 2- In the grievance it has been categorically mentioned that the matter concerns the working of the sub divisional magistrates Sadar District Mirzapur. Public information officer in the office of Chief Minister government of Uttar Pradesh must provide the reason of not forwarding the matter to the sub divisional Magistrate Sadar as closely connected with his working. 3- It is obvious that the matter concerns the noncompliance of the court order by the Lekhpal of the concerned Village Panchayat. Please provide the action taken by the investigation officer to ensure the compliance of the court order. 4- 6 months passed but the order passed by the court of additional sub divisional magistrate was not complied by the concerned Lekhpal of villager Babura, Post Babura, tehsil-Sadar, District Mirzapur. Vivek Jawla, Circle Officer City did not take the steps taken by him to curb this anarchy as an investigation officer in the matter. Please provide the name and designation of the staff belonging to the chief member office who accepted the arbitrary and inconsistent report of the circle officer in the matter. 5- Public information officer must provide the legible copy of the second and third page of the attached PDF document which are illegible.
