ADDENDUM TO WRITTEN REPRESENTATION (DIARY NO: D-120220260008)**BEFORE THE HON'BLE STATE INFORMATION COMMISSION, LUCKNOW Court of Smt. Shakuntala Gautam (Hearing Room S-9)****Appeal No: S-09/A/1948/2024 Yogi M.P. Singh vs. PIO, Office of Tehsildar, Lalganj, Mirzapur****Subject: OBJECTION TO INCOMPLETE/CONTRADICTORY DISCLOSURE AND DEMAND FOR ACTIONABLE ADDRESS DETAILS FOR FIR REGISTRATION.****Most Respectfully Showeth:**

- Tactical Delay in Service:** The Respondent PIO delivered a communication at **11:00 AM today (12/02/2026)**, precisely as the hearing was scheduled to commence. This document was notably addressed to a different party, **Sadhana Tiwari (Case S-09/A/0456/2025)**, and not to the Appellant.
- Incomplete Retirement/Death Information:** The PIO states that the involved officials (Lekhpal Shiv Prasad Yadav, RI Surendra Agrahari, and Tehsildar Santosh Dubey) are "retired and dead". However, the PIO has suppressed the **Date of Retirement**, the **Pension Payment Order (PPO)** details, and the **Permanent Addresses** of these individuals.
- Necessity of Addresses for FIR:** To register a **First Information Report (FIR)** regarding the fraudulent exclusion of a Class-1 heir, the Appellant legally requires the **Last Known Permanent Addresses** recorded in the official Service Books. Providing a generic status of "death" without addresses is a deliberate attempt to shield the perpetrators from legal scrutiny.
- Refusal of "Right to Reason":** The Respondent has explicitly refused to provide the "Right to Reason" for the inheritance exclusion, claiming it is not covered by the RTI Act. This is a direct violation of **Section 4(1)(d)**, which mandates that authorities give reasons for administrative decisions to affected persons.

PRAYER FOR ADDITIONAL RELIEF:

- A.** Direct the PIO to provide the **Permanent Addresses** from the Service Books and the **specific Retirement Dates** of the three named officials to facilitate the registration of an FIR.

- **B.** Reject the PIO's last-minute submission as "Compliance" since it fails the test of **Point-wise Clear Information** ordered on 19/12/2025.
- **C.** Impose the **₹25,000 penalty** for the 400-day delay and for providing contradictory/incomplete information at the very last minute today.
