- 1. Background:** The Appellant filed an RTI application (DIRPR/R/2025/60529) on **25/03/2025**. The application sought 05 points of information regarding meetings, signed proposals, and portal uploads for **Gram Panchayat Manaua** (Block Kon, Mirzapur) for the financial years 2021-22 to 2024-25.
- 2. Failure of PIO and Subordinates:** Although the DPRO Mirzapur (Santosh Kumar) sent a communication (Letter No.-OS/Pt.-7/Public Information/2024-25) dated **01/04/2025** to the Gram Panchayat Secretary, Manaua, directing them to provide the information, **no information has been provided to date.**
- 3. Mockery of Law:** The PIO disposed of the RTI application on the government portal on 02/04/2025 merely by citing an internal communication sent to the

Secretary. This constitutes a "mockery of the provisions of the RTI Act" as the actual information never reached the Appellant.

4. **Non-Compliance with Commission's Orders:** During the previous hearing on **12/12/2025**, the Hon'ble Commission directed the PIO to provide clear, point-wise information. The PIO has willfully defaulted on this judicial direction.
5. **Failure of First Appellate Authority:** The First Appeal filed on 29/04/2025 was not entertained by the Deputy Director (Satish Kumar), necessitating this second appeal .

PRAYER

The Appellant most humbly prays that the Hon'ble Commission:

- **Impose Penalty:** Take action against the PIO under **Section 20(1)** of the RTI Act 2005 for deliberate delay and non-provision of information.
- **Disciplinary Action:** Initiate proceedings against the First Appellate Authority for failing to perform statutory duties.
- **Order Disclosure:** Direct the PIO/DPRO Mirzapur and the Village Panchayat Secretary to provide the requested 05 points of information immediately.
