**Prima Facie Case of Cyber Fraud:** The original grievance provided extensive details, including the Facebook advertisement, website, order details, courier tracking, seller name (Velocity Drop), and the clear fact of receiving a completely spurious item (hair dye) instead of the ordered product (non-invasive blood sugar monitor), establishing a clear case of cheating and online fraud for investigation by the Cyber Cell.

**Request for Transparency:** The applicant is left completely in the dark regarding the action, if any, taken by the Ministry of Home Affairs/Cyber Cell.

**Prayer/Request:**

I humbly request the Appellate Authority to:

Review the closure of Grievance No. MINHA/E/2025/0018101.

Provide a clear, detailed, and reasoned decision (a speaking order) for the disposal of the case, as to what action was taken and why the case was closed.

Reopen the investigation into the alleged cyber fraud and issue necessary directions to the concerned authority to take harsh, effective steps against the fraudsters (Toytingle/Velocity Drop/CAREBUDDYO.MYSHOPIFY.COM) to prevent future cheating of gullible citizens.

I look forward to your prompt and fair intervention in this serious matter.
