### Grievance Description

**Subject: Complaint for registration of FIR against Vijay Gupta for Criminal Intimidation, Financial Fraud, and Persistent Harassment.**

Respected Sir,

I, Radha Gupta, wife of Vinod Kumar Gupta, resident of Kaji Talab, Jangi Road, Mirzapur City, wish to bring the following serious matter to your immediate attention:

1- Background of Debt: The offender, Vijay Gupta (S/O Munna Gupta, resident of Village Gadia, Prithvipur, District Shahjahanpur), borrowed a significant sum of money from my husband, Vinod Kumar Gupta, some time ago.

2- Motive for Harassment: For the past few weeks, whenever my husband requests the return of the borrowed money, the offender resorts to malicious tactics to avoid repayment. Instead of clearing his debt, he has begun a campaign of character assassination and intimidation against me and my family.

3- Threats and Abuse: The offender has been sending highly threatening and abusive messages via WhatsApp and SMS to my mobile number (7398853946). He also makes frequent phone calls using foul language and issuing death threats, claiming that we have "messed with the wrong person" and warning us to "wait for the consequences of his hatred."

**Use of Multiple Numbers:** To bypass our attempts to ignore him, the offender uses multiple mobile numbers, specifically 8953207639 and 9250340186, to ensure persistent harassment.

**Mental Agony:** This continuous harassment has caused severe mental trauma to me and my family. We fear for our physical safety as the offender is using these threats specifically to silence

us regarding the financial debt he owes.

In view of the above facts, I earnestly request you to:

Register a formal FIR against the accused, Vijay Gupta, under relevant sections of the law (including Criminal Intimidation and Harassment).

Initiate an investigation into the offender's location and activities to prevent any physical harm to my family.

Take necessary action to ensure the recovery of the borrowed funds from the offender.

I have attached printed screenshots of the threatening messages and the offender's details as evidence.
