Respected Sir/Madam,

I am writing to provide a follow-up regarding the grievances filed on **March 12, 2026**, concerning the illegal charges and record falsification by **Ramakrishna Sevashram Hospital, Mirzapur**.

Summary of the Pending Matter:

- **Admitted Debt:** The hospital management has admitted their liability for a refund of **₹7,587.00** for payments made on **June 5, 2025** (the date the Ayushman Card was active).
- **Non-Compliance with Digital Norms:** Despite the payment being made via Google Pay, the hospital is refusing a digital refund and demanding a physical visit, which is a violation of RBI transparency guidelines and a tool for further harassment.
- **Falsification of Admission Date:** The hospital continues to report the admission date as **June 4, 2025**, whereas the patient was actually admitted on **June 3, 2025**.

Action Requested: I request that your offices issue a joint directive to the **Chief Medical Officer (CMO) of Mirzapur**, to:

1. Enforce an immediate digital refund of **₹7,587.00** to Google Pay number **7379105911**.
2. Correct the patient's admission date to **June 3, 2025**, in the official PM-JAY database.
3. Hold the hospital accountable for its failure to comply with grievance resolutions for over 6 months.

The delay in this refund and the refusal to follow digital protocols are tarnishing the integrity of the Ayushman Bharat Scheme. I look forward to a time-bound resolution.

Pt Vidhya devi age 75/ F was admitted under Dr K M Chaudary (MBBS MD) General Medicine on 03rd June 2025 in ICU on Cash / Paid Basis because her Ayushman card was not in existence (not made).

From Hospital on 04/06/2025 her attendant (Arun Pratap Singh her son) came to know the Vay Vandana Card (70+) senior citizen ayushman Card and then her attendant gave Adhar Card to prepare Vay Vandana Card on 04/06/2025 in evening around 5 pm and from hospital side it was prepared and from 05/06/2025 morning patient was admitted and converted in ayushman Bharat Yojana from that day hospital not charged single Rupee from patient or from her attendant and also gave ayushman Card in printed form to her attendant available (Arun Pratap Singh her son).

As patient / her attendant accepted that her ayushman card was prepared when she was came in emergency till 04/06/2025 until Vay Vandana Card was prepared by Hospital so any hospital is liable to collect the fee of treatment from the patient which is legal too.
