



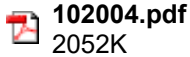

Singh **Respondent:** Public Information Officer (PIO), Office of Chief Medical Officer (CMO), Mirzapur**WRITTEN SUBMISSION AND REJOINDER BY THE APPELLANT****Most Respectfully Showeth:**

The Appellant submits the following facts and documentary evidence, including the response received from the Superintendent, CHC Vindhyachal (dated 30.12.2025), which was issued following RTI application DIRMH/R/2025/65012 dated 11.08.2025.

**1. Admission of Clinical Failure (Point 1 & 5):**

- The Medical Officer, Dr S. K. Singh, officially stated that an X-ray was not considered necessary during the examination of Mahima Maurya.
- This assessment is objectively proven incorrect by the subsequent confirmation of a fracture at Tej Bahadur Sapru Hospital, Prayagraj.

- While the Respondent claims to follow "Standard Operating Procedures (SOP)" directed by the CMO, the failure to identify a fracture indicates a gross violation of medical protocols in a medico-legal case.

**2. Documentary Proof of Administrative Irregularity (Points 2 & 3):**

- The Respondent has provided certified evidence that Dr S. K. Singh has been posted in Mirzapur district since **20.04.2010** and specifically at **CHC**

**Vindhyachal since 21.04.2010.**

- This confirms that the officer has remained at the same station for **nearly 16 years**.
- Such a prolonged posting is a direct violation of the State Government's transfer policy, fostering the stagnation and negligence evidenced in this case.

**3. Confirmation of Lack of Accountability (Point 6):**

- Regarding Point 6, the Respondent explicitly states that **no information regarding departmental action** is recorded in the officer's service record.
- Despite documented clinical errors and policy violations, the CMO's office has taken no corrective action against the concerned official.

—

**4. Failure of the PIO and Statutory Delays:**

- The PIO originally denied information on Points 1, 2, and 3 by incorrectly claiming "third-party" status, which the current evidence proves was a tactic to hide administrative failures.

—

- The information was ultimately provided over **4 months late**, well beyond the 30-day limit mandated by Section 7(1) of the RTI Act.

**PRAYER**

In light of the provided documents and the PIO's failure to comply with the RTI Act's timelines, the Appellant humbly prays that the Hon'ble Commission:

1. **Impose a Maximum Penalty** of ₹25,000 on the PIO (CMO Mirzapur) under **Section 20(1)** for the deliberate delay and initial illegal denial of information.
2. **Recommend Disciplinary Action** under **Section 20(2)** against the PIO for shielding professional negligence and policy violations.
3. **Direct the CMO** to explain why the Medical Officer has been allowed to violate the State Transfer Policy for 16 years.


