* Prayer or Relief Sought	<p>FIRST APPEAL UNDER SECTION 19(1) OF THE RTI ACT, 2005 To, The First Appellate Authority / Superintendent of Police, Office of the Superintendent of Police, Mirzapur, Uttar Pradesh – 231001. Subject: First Appeal against the misleading and evasive response regarding RTI Registration No. SPMZR/R/2026/60090. Details of the Appellant: Name: Naresh Kumar Jaiswal Address: S/O Ashok Jaiswal, Bhatewara, Chilh, Mirzapur, UP – 231001 Contact: 9005697304 Details of the Public Information Officer (PIO): PIO: Manish Kumar Mishra, ASP Operation, SP Office Mirzapur APIO: Circle Officer (CO) Sadar, Mirzapur Grounds for Appeal: I am filing this appeal because the PIO has provided an incomplete, misleading, and legally unsustainable response dated March 13, 2026. The PIO has willfully subverted the RTI process by treating the lowest administrative unit—the Chilh Police Station—as a scapegoat to shield higher-ranking officers from accountability. Failure of Supervisory Due Diligence: My RTI specifically requested the Investigation Report submitted by Circle Officer (CO) Amar Bahadur in September 2025 regarding grievance number 60000250184560 (Point 4) and the Accused Statement of Ashok Kumar Jaiswal (Point 5). These records are held at the Circle Office/SP Office level. Yet, the PIO forwarded the request to Chilh PS, which then claimed the information is not deya (storable/provider) at the station level. This is a circular denial intended to obstruct the truth. Incompetence of the Inquiry Officer: The root cause of this dispute is that the Circle Officer conducted an inquiry</p>	

that failed to conform to standard legal norms. He did not collect or verify the Sale Deeds and Affidavits (Points 1, 2, and 3) despite the claim that the property is unpartitioned ancestral land. By failing to include these in the case file, the CO created a paper vacuum which the PIO is now using to claim the records are not related to the police station. Misuse of Section 6(3): The PIO at the SP Office has constructive possession of all Circle Office reports. Transferring the request to a subordinate Inspector who does not hold CO-level reports is a violation of the RTI Act and an act of administrative indiscipline. Information Requested from the Appellate Authority: I request the Appellate Authority to intervene and direct the PIO to: Provide the Complete Investigation Report of CO Amar Bahadur from September 2025. Provide the Statement of Ashok Kumar Jaiswal where he admitted the land is unpartitioned. Clarify the current status of the Challani Report under Sections 126 and 135 of BNSS dated 18-06-2025, which the station claims is pending in SDM Court Mirzapur without providing a case number. Prayer: I pray that the Appellate Authority takes note of this scapegoating tactic and ensures that the documents held by the Circle Officer are released immediately. I also request disciplinary action against the PIO for providing a nil report by misdirecting the application to a subordinate office. Date: March 30
