It appears that flood relief is being distributed  through brokers at Tehsil Sadar and there is a lack of transparency and accountability in the  disbursement process. This request is filed to ensure transparency as the PIO Tehsildar Sadar is  bound to provide this information within 30 days as prescribed under the RTI Act 2005. Grounds for First Appeal The appellant filed an RTI application on 08 January 2026, requesting information regarding flood-relief applications, beneficiary lists, staff details, and government orders concerning Village Panchayat Nibi Gaharwar, Mirzapur. As per Section 7(1) of the RTI Act, the PIO is legally bound to provide the information within 30 days. No information has been provided to the appellant till date, nor has any intimation of delay, transfer, or rejection been issued, which is a clear violation of the RTI Act. The information sought relates to public welfare, flood relief distribution, and transparency of government schemes, and must be disclosed in public interest under Section 4(1)(b). Failure of the PIO to act within the stipulated time amounts to deemed refusal under Section 7(2) of the Act 4. Relief Sought (Prayer) The appellant requests the First Appellate Authority to kindly: Direct th PIO to provide complete and certified information as requested in RTI Application No. DMOMR/R/2026/60008. Direct the PIO to provide reasons for delay and non-compliance with Section 7(1). Take appropriate action under Section 20 of the RTI Act for willful delay/denial of information, if found justified. Ensure that all requested records, including beneficiary lists,</p>	

orders, memos, and staff details, are supplied in certified form. Provide compensation to the appellant for harassment caused due to unexplained delay, if applicable under Section 19(8)(b).
