4. BRIEF SUBMISSIONS & GROUNDS FOR APPEAL

1. Violation of Section 7(1): The appellant submitted the online RTI application on 10/11/2025. Despite the lapse of the mandatory 30-day period, the PIO provided no response.
2. Deemed Refusal: Per Section 7(2), the failure to respond within the stipulated time constitutes a "Deemed Refusal".
3. Failure of FAA: The First Appellate Authority (FAA) failed to adjudicate or provide relief regarding the appeal filed on 13/01/2026, leading to a total failure of the grievance redressal mechanism under the RTI Act.

4. **Public Interest:** The matter involves personnel facing criminal charges obtaining paid leave, which is a significant matter of administrative integrity and public concern.

5. DESCRIPTION OF INFORMATION SOUGHT

The appellant requested the following information related to grievances GOVUP/E/2025/0091377 and GOVUP/E/2025/0087878:

- Point 1 & 2: Names and designations of staff members currently processing and monitoring these specific grievances.
- Point 3: Certified copies of leave applications submitted by Umesh Kumar Yadav and Mukesh Kumar Yadav for obtaining bail in criminal cases.

6. PRAYER / RELIEF SOUGHT

1. **Direct Information Supply:** Direct the PIO to provide complete, point-wise information immediately and free of cost as per Section 7(6) of the RTI Act.
2. **Penalty under Section 20:** Initiate action and impose penalties against the PIO for the willful denial of information within statutory timelines.
3. **Inquiry:** Inquire into the reasons for the "Deemed Refusal" by the PIO and the subsequent inaction by the First Appellate Authority.
