Grounds for First Appeal This First Appeal is being filed because the PIO has not provided any information within the mandatory 30-day period, as required under Section 7(1) of the RTI Act, 2005. The R was only transferred on 05/03/2026—after an unexplained delay of almost two months—and even after the transfer, no reply has been furnished. The PIO has failed to respond to any of the five specific information points sought, making it a clear violation of Sections 7(1), 4(1)(d), and 6(3) of the RTI Act. 2. Brief Background The information requested concerns: Current status of disciplinary proceedings against 21 officers/employees of Gorakhpur Forest Division. Details of punishments imposed, if any. Reasons for delay, since the case has remained unresolved for almost 4 years. Copy of the Action Taken Report (ATR) submitted by the Forest Department in response to the AG Audit Report (plantation irregularities 2017–2019). Names of the Inquiry Officers handling the pending cases. These matters relate to serious financial and procedural irregularities, and the information must mandatorily be disclosed as per Section 4(1)(b) and 4(1)(d). However, no information has been provided, nor has any exemption been claimed. 3. Specific Violations by the PIO Delay beyond 30 days → Violation of Section 7(1). Failure to provide any information → Violation of Section 7(1). Improper transfer after 52 days → Violation of Section 6(3), which requires transfer within 5 days. No reason given for non-disclosure → Violation of Section 4(1)(d). Repeated evasion despite public interest → Grounds for Section 20 penalty</p>	

proceedings. 4. Relief / Information Requested from the First Appellate Authority The FAA is requested to: (A) Direct the PIO to immediately provide complete information on all 5 points of the RTI: Updated status of disciplinary proceedings against the 21 officials/employees. Names, designations, date of orders, and nature of punishment for each officer (if any punished). Reason for delay if any inquiry is still pending after several years. Certified copy of the ATR submitted to the Government of Uttar Pradesh regarding the AG Audit findings (2017–2019 plantation irregularities in Gorakhpur Division). Names and designations of Inquiry Officers handling the cases. (B) Inquire into the PIO's delay and non-responsiveness, and pass orders as deemed appropriate under Section 19(8). (C) Consider recommending penalty proceedings under Section 20 for: Delay Non-supply of information Failure to perform statutory duties
