REBUTTAL TO THE PIO'S SUBMISSION DATED 01/04/2026

BEFORE THE HON'BLE STATE INFORMATION COMMISSION, LUCKNOW Court
of Smt. Shakuntala Gautam (Hearing Room S-9) Appellant: Yogi M.P. Singh vs.
Respondent: PIO, Office of Tehsildar, Lalganj, Mirzapur

1. Deliberate Suppression of Supervisory & Office Staff

- **The PIO's Claim:** The response only names field staff (Lekhpal, RI) and the Tehsildar, claiming they are "retired and dead".
- **The Rebuttal:** The PIO has failed to identify the **Office Staff/Clerks** and the **Supervisory Officers (Naib Tehsildar/SDM)** under whose monitoring this inheritance was processed.
- **Legal Point:** Administrative and quasi-judicial accountability is not limited to field staff; the **Supervising Authority** is responsible for the final verification of the record.

2. "Death" as a Shield to Escape Accountability

- **The PIO's Claim:** Reporting the death of officials to close the inquiry.
- **The Rebuttal:** The death of an individual does not extinguish the **Public Record**. The PIO has suppressed the **Permanent Addresses** and **Tenure Details** from the Service Books, which are essential for the Appellant to register an **FIR** regarding the fraudulent exclusion of a Class-1 heir.
- **The Rebuttal:** Without the **Date of Retirement** and **PPO details**, the claim of "death" remains unverified and serves only to block legal scrutiny.

3. Violation of the "Right to Reason" (Section 4(1)(d))

- **The PIO's Claim:** Stating that the "Right to reason" is not provided under the RTI Act.

- **The Rebuttal:** This is a flagrant violation of **Section 4(1)(d)** of the RTI Act, 2005, which mandates that public authorities provide **reasons** for administrative or quasi-judicial decisions to affected persons.
- **The Rebuttal:** As inheritance is a **quasi-judicial process**, the absence of a "speaking order" containing reasons violates the principles of natural justice and Constitutional rights.

4. Evidence of Perjury and Procedural Fraud

- **The Rebuttal:** The PIO's office previously recorded a fraudulent "Disposed" status on **05/12/2025**.
- **The Rebuttal:** This was proven false when the PIO appeared on **19/12/2025**, asking for more time due to "SIR work". This documented **perjury** proves a consistent intent to mislead the Commission.

PRAYER FOR RELIEF

The Appellant most respectfully prays that this Hon'ble Commission may:

1. **Reject the PIO's Reply:** Dismiss the submission dated 01/04/2026 as incomplete, misleading, and non-compliant with the order dated 19/12/2025.
2. **Summon Original Records:** Direct the PIO to produce the **Original Note Sheet** and **Mutation Case File (2006)** to reveal the "reason" for exclusion.
3. **Provide Service Book Data:** Direct the PIO to furnish the **Permanent Addresses** and **Tenure** of the involved officials to facilitate the registration of an **FIR**.
4. **Impose Maximum Penalty:** Levy a fine of **₹25,000** under Section 20(1) for the **400-day delay** and the deliberate suppression of information.
