I, Mahima Maurya, the appellant, wish to submit the following facts regarding the RTI response dated **March 26, 2026**, provided by the SHO Vindhyachal on behalf of the PIO:

**1. Contradictory Logic regarding Injury and Signature** The PIO justified taking my husband's signature on the initial complaint by stating I was "injured/hurt" and therefore unable to sign. However, in response to Point 3 of the same RTI, the PIO claimed my injuries were not serious enough to warrant an X-ray. This is a blatant contradiction intended to bypass the victim's legal standing while simultaneously denying necessary medical evidence.

**2. Suppression of Court and Commission Orders** The PIO's response to Point 4 states that no follow-up medical test was carried out because it wasn't "recommended". This is a deliberate misrepresentation. A re-medical examination was conducted specifically because of the **orders of the CJM Court** and the interference of the **Women's Commission** after my repeated representations were ignored by the police. By omitting these judicial and statutory interventions, the PIO has provided incomplete and misleading information.

**3. False** Labelling of True Allegations. In response to Point 6, the PIO labelled my allegations as "false" because they "could not be confirmed". This statement is factually incorrect. A subsequent investigation—forced by the Court—proved my allegations to be **TRUE**. The PIO provided a "false" status to the Commission despite knowing that the matter was under judicial scrutiny and later proved to be correct.

**4. Manipulation of "Medico-Legal" Status** The police continue to ignore medical reports from Prayagraj by labelling them "non-medico-legal." I submit that the police

deliberately blocked the "medico-legal" process by refusing my two dozen requests for a re-medical until the Court intervened.

**5. Illegal Detention and Coercion** The "written complaint" mentioned by the PIO was obtained from my husband, Pramod Kumar Kushwaha, under illegal detention and duress while I was in police presence. The PIO has failed to provide the General Diary (GD) entries that would reveal the true circumstances of his presence at the station during that time.

**Prayer:** 1. I request the Commission to reject the PIO's response as **knowingly false and misleading** under the RTI Act.

2. I pray for the imposition of the **maximum penalty** on the PIO under **Section 20(1)** for the deliberate suppression of facts regarding the CJM Court's orders and the medical truth.


3. Direct the PIO to provide the **General Diary entries** and the **complete investigation report** that eventually proved my allegations true.
