* Prayer or Relief Sought	<p>**Subject** First Appeal Against Incomplete Misleading and Evasive Information Provided by the PIO Administrative Officer on Registration Number UPICM/R/2026/60146 **1 Background of the Case** On 12032026 I filed an RTI application seeking specific details regarding - The registration of Public Information Officers PIOs in District Mirzapur on the official RTI portal - The use of official email IDs up.gov.in and nic.in for communication - The legal validity of using personal WhatsApp for official communications **2 Details of the Impugned Order** The PIO Shri Mumtaz Ahmed responded to my request on 06042026 However the information provided was vague and evasive Instead of addressing the five distinct queries the PIO referred to a CATS Development report for Point No 1 and improperly used the phrase As per Point No 1 to bypass Points 2 3 4 and 5 **3 Grounds for Appeal** - **Failure to Provide Certified Copies Point 3** I requested a certified copy of any Circular or Office Memorandum that allows the use of personal WhatsApp IDs for official RTI delivery The absence of such a document raises concerns about transparency and legality - **Evasive Response on Monitoring Mechanisms Point 4** My query regarding the Commissions mechanism to verify delivery dates contradictions between WhatsAp and Portal dates was ignored suggesting a lack of oversight and accountability among PIOs - **Non Compliance with Supreme Court Guidelines Point 5** The PIO overlooked my request for directions regarding the mandatory use of government emails per Supreme Court guidelines Merely providing a list of registered users does not equate to the necessary enforcement measure - **Admission of Irregularity** Handwritten notes on Page 2 of the response acknowledge that while some PIOs have official IDs they are not using email as required This indicates a failure in the implementation of the RTI Act in District Mirzapur **4 Prayers** In light of the above points</p>	

I request the Honble First Appellate Authority to - Set aside the PIOs response dated 06042026 as non responsive and evasive - Direct the PIO to provide specific point wise and certified information for Points 2 3 4 and 5 of the original application - Clarify the Commissions official stance on using personal social media WhatsApp for delivering statutory information - Initiate an inquiry into the non utilization of official government email IDs by PIOs in District Mirzapur despite their registration ****Declaration**** I hereby declare that the particulars given above are true to the best of my knowledge and belief
