### **1. SUBJECT MATTER OF THE APPEAL**

The Appellant filed an RTI application on **21/08/2024** seeking information regarding the posting details, service duration, and CUG contact numbers of Class I, II, III, and IV employees within the Medical and Health Department of Mirzapur. The primary objective of this request is to verify compliance with the **State Government's New Transfer Policy** and to address administrative inertia caused by long-term stagnation of staff at the same posts.

---

### **2. DOCUMENTED MISCONDUCT BY THE PIO**

The PIO (CMO Mirzapur) has systematically obstructed the flow of information through the following illegal means:

- **Illegal Demand for Justification:** Through communication dated **01/09/2025 (Letter No. 4180)**, the PIO demanded to know the "justification" and "public interest" behind the request. This is a direct and documented violation of **Section 6(2)** of the RTI Act.

- 
- **Misuse of Exemptions:** The PIO sought protection under **Section 8(1)(d)** (Commercial Confidence) to withhold administrative data such as employee posting dates and CUG numbers. Public servant posting details and government-issued contact numbers are public records and cannot be classified as "trade secrets" or "commercial confidence".

### 3. NON-COMPLIANCE WITH COMMISSION'S PREVIOUS ORDER

In the order passed by this Hon'ble Commission on **23/02/2026**, it was explicitly ruled that:

- The PIO's response was "**not correct and not sufficient**".

- The PIO was directed to provide point-wise, clear, and sufficient information before the next hearing date. As of today's hearing, the PIO has failed to provide the requested point-wise details, demonstrating a persistent disregard for the Commission's authority and the provisions of the RTI Act.

○

### 4. PRAYER

In light of the PIO's repeated attempts to shield potential administrative malpractice and violations of the Transfer Policy, the Appellant most respectfully prays that this Hon'ble Commission may:

1. **Impose a Penalty of ₹25,000/-** on the PIO, CMO Mirzapur, under **Section 20(1)** for willfully and without reasonable cause providing "incorrect and insufficient" responses.

2. **Recommend Disciplinary Action** against the PIO under **Section 20(2)** for habitual obstruction and violation of Section 6(2).

○

3. **Direct Immediate Disclosure** of all posting details (Points 1-3) and the status of the Transfer Policy (Point 4) on a sworn affidavit within 48 hours.

Sir, Public Information Officer, who is the chief medical officer of district Mirzapur must provide the following information to the information seeker as follows.**

**1- Provide the posting details of all the first class and second-class employees of the department, the date on which they started service in Mirzapur district and for how long they have been posted, where was their first posting. Also provide their CUG mobile numbers which is necessary in wide public interest. 2- Sir, please provide the posting details of all the third-class employees of the department and the details of the date of commencement of their service in the district and other posting related details, Sir, also provide that from which district they have come to Mirzapur after being transferred. 3- Sir, the posting details of all the class IV employees of the department posted in the district and the details of the date of commencement of service in the district and if they have been transferred from other districts to this district, then also provide the details of that. 4- Sir, please provide to the applicant**

**whether the new transfer policy issued by the state government is being followed in the department or not and if it is being followed, then how has it happened till date, with the step-by-step efforts taken in that direction, the applicant must be informed. Most respected sir new transfer policy attached with this representation which must be taken into account before providing the information to the information seeker by public information officer/chief medical officer Mirzapur. The public information officer must provide the four points information to the information seeker within stipulated 30 days as prescribed under subsection 1 of section 7 of the right to information act 2005.**



### **1. BACKGROUND OF THE CASE**

The Appellant filed an RTI application on **22/08/2024** seeking critical information regarding:

- Expenditure on TB medicines for financial years 2022-23 and 2023-24.
- Government Orders (GOs) allow doctors to prescribe medicines from private stores.
- Reasons for referring patients to private digital X-ray centres despite available government facilities.

### **2. DOCUMENTED MISCONDUCT BY THE PIO**

The Appellant draws the Hon'ble Commission's attention to two contradictory letters issued by the PIO:

- **Letter No. 4180 (01/09/2025):** The PIO illegally demanded "justification" and "public interest" for the request, violating **Section 6(2)** of the RTI Act. They further claimed exemption under **Section 8(1)(d)** (Commercial Confidence).
- **Letter No. 3109 (22/07/2025):** Paradoxically, in another instance, the PIO provided partial budget figures (e.g., ₹5,05,540 for 2022-23), proving that this data is **not** a trade secret and the previous denial was **malafide** (in bad faith).

### 3. NON-COMPLIANCE WITH COMMISSION'S ORDER

In the order dated **23/02/2026**, this Hon'ble Commission ruled that the PIO's response was "**incorrect and insufficient**". The PIO was directed to provide a point-wise, clear, and sufficient disposal of the application before today's hearing. As of this moment:

- - The PIO has failed to provide the **Government Order** requested in Point 4.
- - The PIO has provided misleading information regarding the availability of X-ray services while patients continue to be exploited by private centers.

### 4. PRAYER

In view of the persistent obstruction and the PIO's attempt to shield a potential "private prescription nexus," it is most respectfully prayed that this Hon'ble Commission may:

1. **Impose a Maximum Penalty of ₹25,000/-** on the PIO, CMO Mirzapur, under **Section 20(1)** for willfully providing misleading and insufficient information.
- 
2. **Recommend Disciplinary Action** under **Section 20(2)** for the PIO's habitual violation of **Section 6(2)** by demanding justifications from applicants.
- 
3. **Direct Immediate Disclosure** of the Point 4 information (Government Order on private prescriptions) on an affidavit within 48 hours.

When the medicines are not available in the stores of the tuberculosis centre in district Mirzapur then think about the campaign of the government to eliminate the tuberculosis from the country is only on paper and only means to advertise the government on the false and fabricated grounds. 2 In respect of the information sought by you in point no. 2, District Tuberculosis Center, Mirzapur purchased anti-tuberculosis medicine worth Rs. 22007 in the financial year 2021-22. 3 In respect of point no. 3, no anti-tuberculosis medicine was purchased by the Division Hospital Hazrat Imam Yusuf Hospital, Mirzapur in the financial year 2020-21 and anti-tuberculosis medicine worth Rs. 7650 was purchased by the District Tuberculosis Center, Mirzapur. Chief medical officer, District-Mirzapur who is also the public information officer in the department Medical and health district Mirzapur may provide the following point-wise information to the information seeker. 1- Right to reason is the indispensable part of sound administrative system so provide the reason of prescribing the digital x ray test of the patients in the tuberculosis isolation centre Mirzapur if such facilities are not available in the tuberculosis isolation centre Mirzapur and the next test is sputum test is not carried out in the tuberculosis isolation centre by taking the recourse of digital x-ray test which is costly at the private service provider centres and poor patients cannot afford it including applicant. 2-Provide the fund spent in purchasing the medicines in district T.B.**

**hospital and divisional hospital Hazrat Imam Yusuf hospital Mirzapur city in the current financial year i.e. 2022-23. 3- Provide the fund spent in purchasing the medicines in district T.B. hospital and divisional hospital Hazrat Imam Yusuf hospital Mirzapur city in the current financial year i.e. 2023-24. 4- Provide the Govt order, circular, and office memo which allow prescription of medicines by the doctors working at divisional hospital Hazrat Yusuf Imam Hospital and tuberculosis isolation centre Mirzapur from private medical stores and this practice is currently on its peak. 5- Please provide the reason for non-availability of the entire test facility and medication facility of patients of tuberculosis which is contagious disease, and the government wants to eradicate it quite obvious from its campaign and organisation of a special team for this purpose at the label of central government. Public information officer, Chief Medical Officer Mirzapur must provide 5 points of information within a stipulated 30 days as prescribed under subsection one of section 7 of the right to information act 2005.**
