MOST RESPECTFULLY SHOWETH:

1. That the appellant had filed an application dated 14.08.2025 under Section 6(1) of the Right to Information Act, 2005, seeking point-wise information regarding the functioning and operations of the Cheelh Ghat Police Station, District Mirzapur.
2. That due to the non-provision of information by the respondent/PIO within the stipulated timeframe, the appellant was compelled to file a second appeal before this honourable commission on 17.11.2025.

—

3. That during the hearing dated 23.12.2025, this Honourable Commission was pleased to direct the Respondent/PIO to provide the desired information in a point-by-point tabular format within 15 days, with a strict warning of a ₹25,000 penalty under Section 20(1) of the RTI Act, 2005.
4. That despite the explicit directions of this Honourable Commission, the Respondent/PIO completely failed to comply with the order, remained absent during the subsequent hearing on 25.02.2026, and failed to submit any written statement or compliance report on record.
5. That in the order dated 25.02.2026, this Hon'ble Commission took strong note of this non-compliance, deeming the PIO's conduct "highly objectionable", and extended a final opportunity to the Respondent to provide the information within 15 days, failing which the imposition of the ₹25,000 penalty under Section 20(1) was to be finalised.
6. That as of today, the Respondent/PIO has wilfully, deliberately, and maliciously disobeyed the repeated orders of this Hon'ble Commission dated 23.12.2025 and 25.02.2026. No information, either complete or partial, has been supplied to the appellant to date.
7. That the deliberate inaction and persistent absence of the Respondent/PIO clearly demonstrate a complete disregard for the mandates of the Right to Information Act, 2005, and the authority of this Hon'ble Commission.

PRAYER

In the light of the facts mentioned above, the appellant most respectfully prays that this honourable commission may graciously be pleased to:

- **a) Finalise and impose the maximum statutory penalty of ₹25,000/- (Rupees Twenty-Five Thousand Only) upon the Respondent/PIO under Section 20(1) of the RTI Act, 2005, for deliberate obstruction and non-provision of information.**
- **b) Direct disciplinary proceedings against the concerned Respondent/PIO under Section 20(2) of the RTI Act, 2005, for persistent negligence of official duties.**
- **c) Direct the Respondent/PIO to immediately provide the certified, point-by-point information to the Appellant free of cost, as requested in the application dated 14.08.2025.**

- **d)** Pass any other such order(s) as this Hon'ble Commission may deem fit and proper in the interest of justice.



धारा 6(1)	मांगी गई सूचना/अनुतोष
14.08.2025	इस प्रकरण में अपीलार्थी ने मिर्जापुर जिले के चील्ह घाट थाने की कार्यप्रणाली के बारे में कई अन्य बिन्दुओं पर सूचनाएं मांगी हैं।

उभयपक्ष अनुपस्थित हैं। प्रश्नगत मामले में गत सुनवाई दिनांक 23.12.2025 को जनसूचना अधिकारी से अपेक्षा की गई थी कि अपीलार्थी को वांछित सूचनाएं 15 दिन के भीतर टेबलफार्म में बिन्दुवार (यदि संलग्नक है तो साथ में संलग्न करें) उपलब्ध कराना सुनिश्चित करें एवं कृत कार्यवाही से आयोग को भी अवगत कराएं अन्यथा उनके विरुद्ध "सूचना का अधिकार अधिनियम, 2005" की धारा 20(1) के अन्तर्गत रु0 25,000/- का अर्थदण्ड अधिरोपित किया जाएगा। किन्तु आज सुनवाई के दौरान जनसूचना अधिकारी न तो उपस्थित हैं और न ही उनका कोई लिखित अभिकथन पत्रावली पर उपलब्ध है। यह स्थिति अत्यन्त आपत्तिजनक है।

अतः न्यायहित में जनसूचना अधिकारी को अन्तिम अवसर प्रदान करते हुए अपीलार्थी का मूल आवेदन पत्र संलग्न कर इस आशय की नोटिस निर्गत की जाए कि वांछित सूचनाएं अपीलार्थी को 15 दिन के भीतर उपलब्ध कराना सुनिश्चित करें एवं कृत कार्यवाही से आयोग को भी अवगत कराएं अन्यथा उनके विरुद्ध "सूचना का अधिकार अधिनियम, 2005" की धारा 20(1) के अन्तर्गत रु0 25,000/- का अर्थदण्ड अधिरोपित किया जाएगा।
