For each branch, specify the name, official designation, employee code, and the exact date of current deployment of the serving **Branch Manager** (Scale-I, Scale-II, or Scale-III).
- Regional Office Upper-Rank Hierarchy:** Provide a complete list of all upper-rank/senior executives currently posted at the Regional Office in Mirzapur (including Regional Manager, Chief Managers, Senior Managers, and specialized Officers). Please clearly detail their names, operational designations, specific departments, and their effective dates of joining the Mirzapur Regional Office.
- Stagnation and Cumulative Stay Analysis:** Provide the exact count, names, and current designations of all officers, management executives, and clerical staff who have been continuously deployed within the geographical boundaries of District Mirzapur for **more than 3 consecutive years**,
