**SUBJECT: REJOINDER AND FORMAL LEGAL OBJECTION AGAINST
YOUR INCOMPLETE AND CONTRADICTIONARY REPORT ISSUED VIDE
LETTER NO. 554 DATED 23.06.2026**

Sir,

I acknowledge the receipt of your report issued vide Letter No. 554 dated 23.06.2026, which you sent directly to my email address. I reject your report and place my formal legal objections on record due to the following structural contradictions and ongoing non-compliance:

1. Direct Exposure of Misleading and Contradictory Claims

- In your earlier responses, your office routinely blocked my queries by misapplying the Section 8(1)(j) personal privacy exemption and manually

asserting that the farmer applications stood "Rejected at the Tehsil level".

- In a massive contradiction, your latest report explicitly attaches the Darshan Portal data records showing that all three farmer registrations were **"Approved"** on 09 January 2026.
- This exposure proves that your office deliberately provided misleading, shifting, and evasive statements to cover up processing anomalies.

2. Continued Suppression of the Core Information (The 10-Month Stagnation Log)

- My original RTI application did not merely ask for the final portal status. It explicitly demanded the **daily progress reports, desk movement histories, official noting sheets, and the names/designations of the desk officials** who kept these three specific welfare files stagnant for over 10 consecutive months.
- Simply stating that the files are now "Approved" does not satisfy the core query. You are intentionally withholding the historical movement sheets to shield negligent desk assistants from administrative accountability.

3. Baseless Invocation of Section 8(1)(j)

- Your reliance on Section 8(1)(j) falls flat because Reference No. 20250119514266 belongs directly to me, the Appellant (Mahesh Pratap Singh). A public authority cannot statutorily declare an applicant a "third-party" to his own files.
- The remaining two applications belong to my immediate biological younger brothers, Shri Arun Pratap Singh and Shri Keshav Pratap Singh. They share a joint agricultural interest and have fully authorized this tracking. Therefore, no third-party privacy breach exists.

4. Absolute Binding Nature of the Proviso to Section 8(1)(j)

- The processing logs, welfare dispersals, and portal accountabilities of public servants are matters of transparent public operation.
- Under the statutory Proviso to Section 8(1)(j) of the RTI Act, 2005, information which you cannot deny to the State Legislature shall not be denied to any citizen. The efficiency or deliberate stagnation of a government agricultural desk is highly reportable to the U.P. State Legislature, and you cannot legally withhold it.

DEMAND FOR IMMEDIATE COMPLIANCE

I hereby call upon you to immediately break this illegal embargo on the records. Provide complete, certified, and unredacted copies of the **daily progress reports, desk movement logs, and official noting remarks** for Reference Nos.

20250119514266, 20250119192467, and 20250119512524 within 7 days of receiving this communication.

Please note that I am placing this objection directly on your office record in response to your direct communication. Once the Honorable U.P. State Information Commission serves the formal notice for the upcoming hearing on 12 August 2026, I will submit these facts, along with your contradictions, directly to the Commission to pray for maximum statutory penalties under Section 20(1) of the RTI Act, 2005.

To: The First Appellate Authority (FAA) / Additional Director Agriculture Office of the Directorate of Agriculture, Uttar Pradesh.
Subject: First Appeal under Section 19(1) of the RTI Act 2005 against arbitrary denial of information by PIO DDA Mirzapur. Ref: RTI Registration Number DRAGR/R/2025/60357 dated 26/12/2025. Honorable Sir, I, Yogi M P Singh, am filing this appeal because the Public Information Officer (PIO), Deputy Director of Agriculture, Mirzapur, has provided a misleading and arbitrary response to my application. The PIO has willfully misused the provisions of the RTI Act to shield administrative delays and lack of accountability. Grounds of Appeal: 1- Misuse of Section 8(1)(j): The PIO denied points 1, 2, and 3 claiming the information is personal. This is legally flawed. The application IDs (20250119514266, 20250119512524, and 20250119192467) belong to my younger brothers and myself. As the applicant and a family member, I am not a third party.

Furthermore, the daily progress of a government file and the names of officials handling public schemes like PM-KISAN are matters of public duty, not private life. 2- Public Interest: The applications have been pending for over 10 months in Vicharadheen status. The citizens have a right to know which official (Lekhpal or Clerk) is responsible for this delay. Disclosure of names and designations of such officials is necessary for transparency and does not constitute an invasion of privacy. 3-

Violation of Section 4: The PIO claimed no knowledge of a Citizen Charter or Government Order stipulating time limits for registration.

Under Section 4(1)(b) of the RTI Act, every department is mandatory required to publish its norms and timelines. This denial shows a complete lack of transparency in the Mirzapur office. 4- Failure to Transfer: Regarding the Central Grievance (DOAAC/E/2025/0045542), if the PIO truly had no record, they were legally bound under Section 6(3) to transfer the query to the concerned Nodal Officer. A flat denial is a mockery of the Act. Prayer: I request the

Honorable Appellate Authority to set aside the PIOs order and direct the PIO to provide certified copies of all requested documents, including the daily progress report and the Citizen Charter, within the stipulated time.
