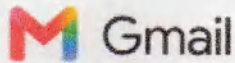

Since these financial and tax data volumes are highly extensive and voluminous, generating physical paper photocopies is completely unfeasible. This electronic submission satisfies your requirement to produce the records.

I request the Investigating Officer and the Superintendent of Police, Mirzapur, to take note of the following facts and refrain from summoning me to waste my time at the Cyber Police Station:

- **TIS Already Provided and Signed:** I have already submitted the complete Taxpayer Information Summary (TIS) directly to your office, with every single point personally verified and signed by me to confirm the identity theft.
- **Central Government Verification:** The **Directorate of Income Tax (Intelligence & Criminal Investigation)** has already thoroughly investigated these identical records, concluded that my PAN (GSWPS0850Q) was criminally misused by third parties for bogus HRA claims, and marked my tax liability as **NIL**.
- **Personal Circumstances:** Yesterday was the death anniversary of my mother. Given this deeply solemn time for my family, I request that the police show basic administrative empathy and do not waste my time with repetitive personal appearances for documents that are already in your possession.

As recorded in your own **Case Diary Entry No. 44**, your office already holds the definitive name and Bengaluru address of the chief impersonator ("Mahesh Pratap Singh, Son of Ashwathappa," residing at Singasandra, Bengaluru). Kindly direct your

teams to execute a physical arrest of the actual fraudsters rather than repeatedly troubling an elderly victim.

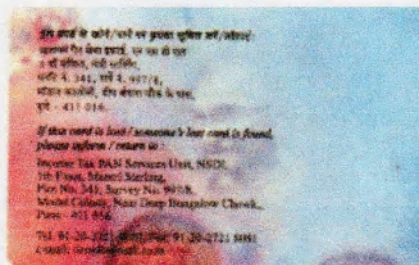

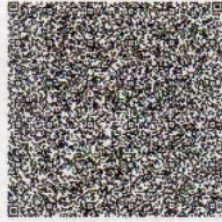

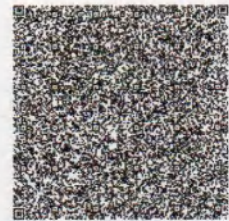
