Prayer or Relief Sought
I respectfully prefer this First Appeal under Section 19(1) of the Right to Information Act 2005 against the order of the CPIO dated 27/07/2026 in RTI Registration No MIINM/R/E/26/00014. The CPIO has rejected the requested information by invoking Section 8(1)(j) of the RTI Act stating that DIR 12 SRN AC0027932 is a private document containing personal information. The denial is legally unsustainable for the following reasons. The information sought relates to a statutory filing made before the Registrar of Companies under the Companies Act 2013. Such records are maintained by a public authority in discharge of statutory functions and cannot be treated as purely personal information. The exemption under Section 8(1)(j) applies only where disclosure has no relationship to any public activity or public interest. A statutory filing before the Registrar of Companies is directly connected with public administration corporate governance and statutory compliance. The CPIO has not recorded any finding explaining how disclosure would amount to an unwarranted invasion of privacy. A mere reference to Section 8(1)(j) without proper reasoning does not satisfy the requirements of the RTI Act. The CPIO has also failed to consider the proviso relating to larger public interest. The requested record concerns statutory filings maintained by the Registrar of Companies and its disclosure serves the interest of transparency accountability and verification of official records. If any portion of the document contains personal particulars capable of protection the CPIO was required to consider severability under Section 10 of

the RTI Act and provide the remaining record after masking only the exempt portions. Complete denial of the entire document is contrary to the Act.

The order is a non speaking order as it does not explain why the exemption applies to each part of the requested information nor does it consider whether partial disclosure is possible.

I therefore request the First Appellate Authority to set aside the order of the CPIO and direct disclosure of the requested information. Alternatively the CPIO may be directed to provide a copy after redacting only those portions if any which are specifically exempt under the RTI Act in accordance with Section 10.

Any other relief considered appropriate in the interest of justice transparency and accountability may also kindly be granted.

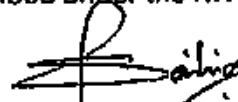

Prayer or Relief Sought Subject: First Appeal under Section 19(1) RTI Act against refusal in MIINM/R/T/26/00051 I respectfully appeal against the CPIO reply dated 17/08/2026 refusing the entire request by stating that DIR-12 SRN AC0028412 is a private document containing personal details and is therefore exempt under Section 8(1)(j). The original RTI did not seek unrestricted personal information. It sought existing official records relating to examination and processing of SRN AC0028412, including status, file notings, office remarks, official correspondence, notices, replies, reports, decisions, file movement, officer designations, applicable instructions or timelines and electronic workflow or audit records held by the public authority. The CPIO has not identified the specific information or record which is exempt, nor explained how Section 8(1)(j) applies to each category requested. A blanket refusal of distinct official records is therefore not justified. Even if any record contains genuinely exempt personal information, Section 10 requires disclosure of the non-exempt portion after reasonable severance. Exempt material cannot justify withholding separable official and administrative information.

The information sought concerns the processing and functioning of a public authority in relation to an identified MCA filing. File status, movement, officer designation, official noting, procedural records, decisions and applicable instructions require separate consideration from private personal information.

Under Section 19(5), the burden of establishing that the denial was justified lies on the CPIO. I therefore request the FAA to examine the refusal item-wise and direct disclosure of all information not lawfully exempt.

I respectfully request that the FAA:

1. Set aside the blanket refusal dated 17/08/2026 and allow the appeal to the maximum extent permitted by law.
2. Direct item-wise reconsideration of the original RTI request.
3. Direct certified copies of all non-exempt file notings, status and file movement records, official correspondence, notices, replies, reports, decisions, officer designations and applicable instructions or timelines relating to SRN AC0028412.
4. Apply Section 10 and provide separable non-exempt portions after redacting only specifically exempt personal information, if any.
5. If any particular record or portion is withheld, identify it and state the precise statutory exemption and reasons for its applicability.
6. Provide information held electronically in electronic form wherever practicable.

The appeal seeks only existing information and records held by the public authority and does not seek any opinion, explanation, creation of information or adjudication of the underlying corporate dispute.

I request a reasoned decision under Section 19(6) within the prescribed period. In case of continued denial, I reserve my right to pursue the statutory remedy under Section 19(3).

If any requested record does not exist or is not maintained, kindly state the same specifically against that point. Where records are available for inspection, kindly permit inspection under Section 2(j) and provide certified copies of identified records.

The FAA is respectfully requested to pass a reasoned and point wise order under Section 19(6), addressing each information point and not dispose of the appeal by a blanket confirmation of the CPIO reply. The statutory burden under Section 19(5) may also kindly be kept in view.
