



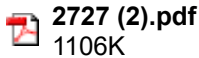

SUBJECT: SUBMISSION HIGHLIGHTING MISLEADING, EVASIVE AND NON-RESPONSIVE DISCLOSURE BY THE RESPONDENT PUBLIC INFORMATION OFFICER, AND ADMINISTRATIVE WRONGDOING AT THE OFFICE OF THE DEPUTY DIRECTOR OF AGRICULTURE, MIRZAPUR

Respected Madam,

The Appellant most respectfully submits this written representation for kind consideration of this Hon'ble Commission at the hearing fixed for 12.08.2026, and begs to state as follows:

I. BRIEF BACKGROUND

1. The Appellant filed an application dated 26.12.2025 (Registration No. DRAGR/R/2025/60357) under Section 6(1) of the Right to Information Act, 2005 before the Public Information Officer, Office of the

Deputy Director of Agriculture (“DDA”), Mirzapur, seeking five specific categories of information concerning three farmer registration applications submitted on the Darshan Portal on 19.01.2025, bearing Reference Nos. 20250119514266, 20250119512524, and 20250119192467, belonging respectively to the Appellant's own family — Sri Arun Pratap Singh, Sri Mahesh Pratap Singh (the Appellant, also known as Yogi M.P. Singh), and Sri Keshav Pratap Singh, all sons of Late Sri Rajendra Pratap Singh.

2. The information sought, in substance, was: (i) the daily progress report on processing of the three applications; (ii) the names and designations of officials with whom the files remained pending; (iii) a certified copy of any written objection, rejection remark, or reason recorded for keeping the applications in “Vicharadheen” (Under Consideration) status for over ten months; (iv) the Citizen Charter/Government Order prescribing the maximum time limit for disposal of such applications; and (v) the status of action taken on a related Central Government grievance bearing Reference No. DOAAC/E/2025/0045542 dated 10.12.2025.

3. By its order dated 23.06.2026 passed in the present Second Appeal, this Hon'ble Commission directed the Respondent to complete the desired action and to submit its written response at least two days prior to the next hearing. In compliance, the Respondent PIO issued a letter dated 10.08.2026 (Patrank 2740/Jan-Suchna/Aapatti/2026-27), purporting to respond point-wise to the Appellant's objections dated 23.06.2026.

4. It is respectfully submitted that the said reply dated 10.08.2026, and the conduct of the Respondent's office throughout these proceedings, is misleading, evasive, and non-responsive, and discloses a pattern of administrative wrongdoing that this Hon'ble Commission is respectfully requested to examine, for the detailed reasons set out below.

II. THE RESPONDENT'S REPLY DATED 10.08.2026 DOES NOT ANSWER THE INFORMATION SOUGHT

5. The Respondent's reply dated 10.08.2026 addresses four numbered objections raised by the Appellant. A plain reading shows that the identical boiler-plate response — that one applicant is the Appellant himself and the other two are his real brothers, a fact allegedly not disclosed earlier — has been repeated verbatim against all four objections, including objections (Objection Nos. 2 and 4) that concern the processing timeline, the Citizen Charter, and the binding proviso to Section 8(1)(j), and have nothing to do with third-party identity at all.

6. Not one of the five original queries has been answered on its own terms. No daily progress report has been furnished. No names or designations of the responsible officials have been disclosed. No written order, note-sheet entry, or recorded reason for the ten-to-fourteen-month pendency has been produced. No Citizen Charter or Government Order prescribing a time limit has been supplied. No update on the Central Government grievance DOAAC/E/2025/0045542 has been given. The reply is, in substance, silent on the very information that was sought, while creating an appearance of compliance through repetition of an unrelated remark.

III. THE RESPONDENT HAS MISLED THE APPELLANT AND THE COMMISSION BY SUBSTITUTING AN UNRELATED RECORD FOR THE INFORMATION SOUGHT

7. In place of the information sought, the Respondent has annexed a printout from the Darshan Portal showing that the three applications stand “Approved” (स्वीकृत), and has represented this as a complete answer. It is submitted that this annexure does not relate to the disposal of the original applications dated 19.01.2025 at all, but reflects a separate and subsequent enrolment under the AgriStack Farmer Registry, a distinct Central digital initiative for identity and land verification, in which the Appellant's brother Sri Arun Pratap Singh was enrolled only on 10.01.2026 and auto-approved by the system on 11.01.2026 — nearly a full year after the original applications were filed and left pending.

8. The two processes are administratively and technically distinct: the Darshan Portal registrations (Reference Nos. 20250119514266, 20250119512524 and 20250119192467) remain, on the Respondent's own record, undisposed and unexplained; the Farmer Registry enrolment is a separate identity-verification exercise that generates an entirely different Farmer ID. No document produced by the Respondent establishes, or even asserts, that the 2026 Registry approval constitutes formal disposal of the 2025 applications. Presenting the later, unrelated approval as if it discharges the duty to answer the RTI application amounts to furnishing misleading information to both the Appellant and this Hon'ble Commission, contrary to Section 7 of the Act, which obliges a Public Information Officer to furnish the information actually sought.

IV. THE VERY SPEED OF THE 2026 APPROVAL CONFIRMS THAT NO GENUINE OBSTACLE EVER EXISTED

9. It is significant that once the same underlying identity and land records were placed before the AgriStack Farmer Registry system in January 2026, all three applications were verified and approved within one to two days, without any manual intervention (recorded as "Auto approved by system"). This demonstrates that there was no genuine, unresolved impediment of identity or land ownership capable of justifying a fourteen-month silence on the original applications. Had the same records been examined with ordinary diligence in 2025, there was no reason disposal could not have occurred equally promptly.

V. SUSPENSION OF PM-KISAN BENEFITS TO SRI ARUN PRATAP SINGH ON A GROUND ALREADY CONTRADICTED BY THE DEPARTMENT'S OWN RECORDS

10. The Respondent's own office, by letter dated 26.02.2026 (Patrank 6644/IGRS Complaint/2025-26), informed Sri Arun Pratap Singh that his PM-KISAN instalments had been withheld at the Central Government level on the ground of "Incomplete identity of previous landowners." This ground is directly contradicted by the Respondent's own records: (a) the legal succession in respect of the land of Late Sri Rajendra Pratap Singh was already finalised by order of the Revenue Inspector, Chhanbey, dated 18.10.2021 (Succession Case No. 20211619901000010679); (b) the Farmer Registration Form itself, generated and approved by an office under the same Department in January 2026, expressly records the identifier as "स्व। राजेन्द्र प्रताप सिंह" (Late Rajendra Pratap Singh), showing that the successorship position was known and accepted at the time of approval; and (c) two PM-KISAN instalments of Rs. 2,000 each were in fact credited to Sri Arun Pratap Singh's India Post Payments Bank account on 24.02.2025, establishing that his Aadhaar seeding, bank mapping, and eligibility were functional and verified well before the stated ground of suspension arose. No written order or reasoned note explaining the subsequent suspension, despite this settled position, has been placed on record either before the Appellant or before this Hon'ble Commission.

VI. THE DEPARTMENT'S OWN ADVICE TO "RE-APPLY ONLINE" IS STRUCTURALLY IMPOSSIBLE AND WAS NEVER A GENUINE REMEDY

11. Officials of the Respondent's Department, including the local Lekhpal, are stated to have advised the family to "apply online again." It is submitted that this advice was incapable of being acted upon: a farmer who already holds a live, registered application number — as all three brothers do — is barred by the portal itself from filing a fresh application against the same Aadhaar/identity. Advice that the system itself makes impossible to follow cannot be treated as a bona fide remedial step; at best it reflects a failure to examine the applicant's existing file, and at worst it operated to keep the matter indefinitely unresolved without any formal order being passed that could be challenged or reviewed.

VII. SELECTIVE AND UNEXPLAINED DIFFERENTIAL TREATMENT AMONG IDENTICALLY PLACED APPLICANTS

12. It is a matter of record that the Appellant's own PM-KISAN benefits have continued without interruption, while the applications and/or payments of his brothers, Sri Arun Pratap Singh and Sri

Keshav Pratap Singh — arising from the same family, the same succession order, the same village records, and processed by the same officials — have remained stalled or suspended. No written record has been produced by the Respondent explaining why identically placed applicants, holding parallel documentation, received materially different treatment. Such an unexplained divergence is itself probative of arbitrary and selective administrative action, and is a matter this Hon'ble Commission may legitimately call upon the Respondent to justify with documentary evidence, failing which an adverse inference would be warranted.

VIII. THE PATTERN IS CORROBORATED BY CONTEMPORANEOUS GRIEVANCES ALREADY ON THE PUBLIC RECORD

13. The above pattern is independently corroborated by three grievances filed on 16.03.2026 through the CPGRAMS/IGRS mechanism: (a) Registration No. GOVUP/E/2026/0032893, addressed to the Hon'ble Chief Minister, U.P., alleging that a local Lekhpal solicited an illicit payment and, upon refusal, gave misleading advice despite the Farmer Registry already reflecting approval; (b) Registration No. DOAAC/E/2026/0006921, addressed to the Department of Agriculture and Farmers Welfare, Government of India, seeking a Central inquiry and manual land-seeding; and (c) Registration No. GOVUP/E/2026/0032916, which specifically places all three Darshan Portal reference numbers (20250119514266, 20250119512524, 20250119192467) and their corresponding Farmer Registry IDs on record before the State Government, describing the fourteen-month pendency as an “Aadhaar database lock” caused by the Respondent's inaction. None of these grievances have been met with any documentary rebuttal from the Respondent; they remain either “under process” or merely forwarded between authorities.

IX. CUMULATIVE SUBMISSION

14. It is respectfully submitted that the cumulative effect of the foregoing — (i) a reply that repeats an irrelevant remark against unrelated queries; (ii) the substitution of an unconnected, later approval for the disposal actually sought; (iii) reliance on a ground for suspending benefits that the Department's own records contradict; (iv) an administrative “remedy” that the portal itself renders impossible; (v) unexplained differential treatment of identically placed applicants; and (vi) an absence, at every stage, of any written order or recorded reason — amounts to more than mere administrative delay. It reflects a considered pattern of misleading disclosure designed to give the appearance of compliance with the RTI Act and with the directions of this Hon'ble Commission, without ever engaging with the substance of what was asked, and without accounting for the wrongdoing alleged at the level of the Department's field officials.

X. PRAYER

In view of the foregoing, the Appellant most respectfully prays that this Hon'ble Commission may be pleased to:

1. Direct the Respondent to furnish a specific, point-wise reply to each of the five queries in the original RTI application dated 26.12.2025, supported by certified copies of the actual daily progress reports, note-sheets, and orders (if any) relating to Reference Nos. 20250119514266, 20250119512524 and 20250119192467, and not by reference to the unrelated Farmer Registry/AgriStack record;
2. Direct the Respondent to place on record, in writing, the specific reason(s) for keeping the said three applications in “Vicharadheen” status for over fourteen months, failing which this Hon'ble Commission may be pleased to draw an adverse inference that no such reason exists;
3. Direct the Respondent/District Magistrate, Mirzapur, to forthwith complete the pending land-seeding and regularise the withheld PM-KISAN instalments of Sri Arun Pratap Singh and dispose

of the application of Sri Keshav Pratap Singh, in each case by a reasoned, written order communicated to the party concerned;

4. Examine whether the conduct of the Respondent in furnishing misleading and non-responsive information warrants action under Section 20 of the Right to Information Act, 2005; and

5. Pass such other and further order(s) as this Hon'ble Commission may deem just and proper in the facts and circumstances of the case.

The Appellant shall be grateful.

Furthermore, I give my consent to use my data available in Pradhan Mantri Kisan Samman Nidhi, Pradhan Mantri Fasal Bima Yojana, State Direct Benefit Transfer Project, and other schemes of the Agriculture Department, as well as Record of Rights data of the Revenue Department, for the creation of required Farmer Registry databases to be used for the Digital Public Infrastructure. I do hereby, on a voluntary basis, authorize the Board of Revenue Uttar Pradesh/ National Informatics Centre (NIC) to share my Aadhaar data (excluding my biometric data), provided by me for State Farmer Registry under the Agri Stack Scheme of Government of India, with the Revenue Department Land Record Database. ****Subject: Petition for a high-level inquiry regarding local corruption, administrative harassment, and the wrongful declaration of ineligibility under the PM-Kisan Samman Nidhi Scheme.****

****Respected Sir,****

I, Arun Pratap Singh, son of Late Rajendra Pratap Singh, resident of Village and Post Neebi Gaharwar, Block Chhanbey, District Mirzapur, am submitting this petition with a heavy heart. I am bringing to your immediate attention a distressing case of corruption and administrative high-handedness where an eligible farmer has been declared ineligible simply for refusing to comply with illicit demands.

****The comprehensive details of the matter are as follows:****

****Firstly, regarding the confirmation of eligibility and prior payments:**** My application for the PM-Kisan scheme was originally approved after a rigorous and lengthy inquiry lasting over a year. Consequently, on February 24, 2025, I successfully received two installments of 2,000 rupees each (totaling 4,000 rupees) in my India Post Payments Bank account, ending in 1236. This successful transaction serves as irrefutable proof that my Aadhaar seeding, bank mapping, and initial eligibility were fully verified and functional at that time.

****Secondly, concerning the status of legal succession and land records:**** Following the demise of my father, the Revenue Inspector of Chhanbey passed an official order on October 18, 2021 (Succession Case No. 20211619901000010679), recording my name and my family members in the Khatauni. According to the current land records, I am the legally recognized co-owner of multiple plots, including Gata numbers 1351, 217, 569, and others.

****Thirdly, in relation to digital compliance and AgriStack enrollment:**** In accordance with the government's digital initiatives, I completed my "Farmer Registry" (AgriStack) enrollment on

January 10, 2026. Furthermore, my registration (Enrollment ID: 9_170_1000_211126_005390) was officially *****"APPROVED"***** and marked as *****"Registered-Active"***** by the system on January 11, 2026, generating Farmer ID 21045534187.

****Fourthly, regarding the deliberate technical obstruction and corruption:**** Despite these clear digital proofs, a misleading report was submitted by the local Lekhpal suggesting that I should "apply online again". However, as a registered farmer with an existing ID, the system does not allow a re-application therefore, this instruction was a tactical move to avoid the mandatory duty of land seeding after I refused to provide a bribe.

****Lastly, regarding the misleading disposal of my grievance:**** In response to my IGRS complaint, the Deputy Director of Agriculture, Mirzapur, stated on February 26, 2026, that my payments were stopped due to an "Incomplete identity of previous landowners". This is highly contradictory because the legal succession was completed in 2021 and my Farmer Registry was approved in 2026. Using the identity of a deceased landowner as a pretext to block a verified account is a direct attempt to harass a citizen and protect local corruption.

****Prayer:****

Therefore, I humbly request your office to:

1. Conduct a formal inquiry through an independent agency into this matter and take punitive action against the guilty officials.
2. Direct the District Magistrate of Mirzapur to immediately complete the "Land Seeding" on the portal based on my approved Farmer Registry ID: 21045534187.
3. Ensure the release of all pending installments for the years 2025 and 2026 into my linked bank account.

I am Arun Pratap Singh, a resident of Village Nibi Gaharwar, Mirzapur, Uttar Pradesh. I am writing to formally complain about the wrongful suspension of my PM-Kisan Samman Nidhi benefits. Despite fulfilling all necessary requirements, my payments have been halted, and I seek your immediate intervention.

**Details of the Complaint:**

1. **Established Eligibility:**

- My eligibility was confirmed through a thorough inquiry, leading to the successful credit of two installments (totaling ₹4,000) into my India Post Payments Bank account on February 24, 2025.
- This indicates that my Aadhaar seeding and bank mapping are functioning correctly.

2. **Approved Digital Status:**

- I enrolled in the AgriStack Farmer Registry, which was marked as "APPROVED" and labeled "Registered-Active" on January 11, 2026, with Farmer ID 21045534187.

3. **Legal Land Ownership:**

- I hold legal ownership of land in Village Nibi Gaharwar (Gata numbers 1351, 217, 569, etc.), following a succession order dated October 18, 2021, transferring the property from my late father, Rajendra Pratap Singh, to me.

4. **Administrative Issues:**

- Despite my verified records, local officials have suspended my payments, citing an error: "Incomplete identity of previous landowners."

- I have been incorrectly instructed to "re-apply online," which is not possible for a registered farmer. This seems to be an avoidance of the necessary duty of Land Seeding on the portal.

****Specific Requests:****

1. ****Inquiry into Administrative Malpractice:****

- I request an investigation into why my verified digital status and legal succession documents are being overlooked by the local authorities.

2. ****Manual Land Seeding:****

- I urge the Central Ministry to direct the State Nodal Officer to conduct manual Land Seeding for my records to address this situa

In compliance with government orders, three registration applications were submitted on January 19, 2025, but they have remained stuck in "Vicharadheen" status for approximately 14 months.

- 20250119192467 (Keshav Pratap Singh)

****Administrative Deadlock:****

The DDA Mirzapur has failed to either approve or reject these files. This "Under Consideration" status effectively locks our Aadhaar numbers, making it technically impossible to follow the department's advice to "re-apply online".

****Conclusive Evidence:****

All three applicants are already "APPROVED" and "Active" in the UPFR AgriStack Farmer Registry as of January 2026, with the following Farmer IDs:

- 21045534187
- 78123253778
- 48187466089

These digital records were auto-approved through API verification, proving that all previous land

record objections are legally void.

I request your immediate intervention to direct the DDA Mirzapur to link these verified Farmer IDs to the pending applications and release all withheld installments for 2025 and 2026.
