* Prayer or Relief Sought	Subject/Reference: First appeal against non-supply of information within the time prescribed under Section 7(1) of the RTI Act, 2005, against RTI Application Registration No. SPSRN/R/2026/60184 dated 21.07.2026, filed before the PIO, Office of the Superintendent of Police, Bhadohi. Grounds of Appeal: Point 1: That the Appellant had filed an application dated 21.07.2026 under Section 6(1) of the Right to Information Act, 2005 before the Public Information Officer (PIO), Office of the Superintendent of Police, Bhadohi, seeking information on nine specific points concerning the inquiry conducted into grievance Registration Nos. GOVUP/E/2026/0067113 dated 26.05.2026 and GOVUP/E/2026/0075864, and the current status of grievance Registration No. GOVUP/E/2026/0093297 dated 21.07.2026. Point 2: That the said application was duly registered on the RTI Online Portal vide Registration No. SPSRN/R/2026/60184 dated 21.07.2026, and continues to reflect the status "RTI REQUEST RECEIVED as on 21/07/2026," with no further update. Point 3: That under Section 7(1) of the RTI Act, 2005, the PIO is under a statutory obligation to either furnish the information sought or communicate a rejection with reasons under Sections 8 or 9 of the Act, within thirty (30) days of receipt of the request. The said period expired on 20.08.2026. Point 4: That as on date, more than thirty (30) days have elapsed since filing, and neither has the information been supplied nor has any order of rejection been communicated to the Appellant. Point 5: That this failure amounts to a deemed refusal within the meaning of Section 7(2) of the Act, entitling the Appellant to prefer this appeal under Section 19(1) of the Act. Point 6: That the information sought is not exempt under Section 8 or Section 9 of the Act and pertains directly to the inquiry into the Appellant's own grievance, materially affecting his legal rights and remedies. Point 7: That the inordinate an	

unexplained delay has caused serious prejudice to the Appellant and defeats the object and purpose of the Right to Information Act, 2005. Prayer: It is most respectfully prayed that this Hon"ble First Appellate Authority may be pleased to: Point 1: direct the Public Information Officer, Office of the Superintendent of Police, Bhadohi, to immediately and without further delay furnish complete and accurate point-wise information against all nine points sought vide RTI application dated 21.07.2026, Registration No. SPSRN/R/2026/60184; Point 2: call for an explanation from the PIO for the failure to dispose of the application within the time prescribed under Section 7(1) of the Act, and consider appropriate action, including reference for penalty proceedings under Section 20 of the Act, if warranted; Point 3: pass such other order(s) or direction(s) as this Hon"ble Authority may deem fit and proper in the facts and circumstances of the case, in the interest of justice.

* Description of Information Sought	Please provide the information within stipulated time and do not repeat earlier deliberate attempt of overlooking RTI. Respected Sir/Madam, This application is filed regarding the public appointment of Umesh Kumar Singh, son of Late Lal Bahadur, under Case No. S10-A-1469/2024. The original appointment was issued under Order No. D-494/Adhasthan/2007 dated 31.07.2008 authorised under U.P. Shasanadesh No. 464/1-9-1-08-137sa/2007-TC dated 28.03.2008, with the Selection Committee recommendations finalised on 28.07.2008. I had earlier filed an RTI application dated 20.02.2026 on this very subject, registered vide Registration No. DIRLB/R/2026/60148. Under Section 7(1) of the Right to Information Act, 2005, the Public Information Officer was statutorily bound to furnish the information sought, or communicate a rejection with reasons under Sections 8 or 9 of the Act, within thirty days of receipt of that application, that is on or before 22.03.2026. No information, part information, or order of rejection has been communicated till date, which constitutes a clear violation of Section 7(1) of the Act by the Public Information Officer. As the window to appeal that non response under Section 19(1) has also since lapsed, I am filing this application afresh under Section 6(1) of the Act, requesting that the following information now be supplied within the time prescribed by law Point 1: Names of all newspapers in which the vacancy for the post of Safai Karmachari was advertised in early 2008, along with a certified copy of the advertisement clipping. Point 2: A certified list of the full names and designations of all members who constituted the Selection Committee that recommended these appointments on 28.07.2008. Point 3: The current official posting details and department of each member of the said 2008 Selection Committee. Point 4: A certified copy of the official Selection Criteria and Appointment Mechanism guidelines followed by the committee, as per the U.P. Municipal Corporation Service Rules, 1962. Point 5: The complete list of all candidates selected and appointed under the OBC and ST categories through the same selection process referenced in Order No. D-494/Adhasthan/2007. Point 6: Certified copies of the Minutes of the Meeting of the Selection Committee held on 28.07.2008 concerning finalisation of the sanitation staff appointments. Point 7: The name and designation of the officer or clerk who conducted the initial verification of high school and residency documents for the	

candidates in August 2008. The requisite RTI fee of Rs. 10 is enclosed. Kindly furnish the information in printed form to the address given below, within thirty days as prescribed under Section 7(1) of the Act, and treat the PIO earlier default as noted above for record purposes.
